# Monday, April 26, 2021

# Council President Michael Nenadovich called the Caucus Meeting to order at 6:30 p.m.

Clmn Vaughn moved to excuse Clmn Donahue from the Caucus Meeting and Clmn Tagliarini seconded. His motion stood approved by 5 Yes (Vaughn, Dudley, Nenadovich, Blake, Tagliarini) and 1 Absent vote.

Clmn Tagliarini then moved to accept the Caucus Meeting Minutes for Monday, April 12, 2021. Clmn Vaughn seconded. His motion stood approved by 5 Yes (Tagliarini, Vaughn, Dudley, Nenadovich, Blake) and 1 Absent (Donahue) vote.

Clmn Dudley brought up numerous problems concerning Terrace Construction on 4900 131st Street and wanted to bring the company before the right committee. He found that the Building Department did not know what kind of operation they are running. Going on, the Councilman stated that a number of safety problems also existed at the Bozeman Company. After some discussion, the consensus was for Mayor Burke, Commissioner Moro and Clmn Tagliarini to gather to look into those matters.

Clmn Blake announced that he would call a Recreation Committee meeting (likely on May 12, 2021) for Director Paul Birk to talk about summer recreation.

Clmn Vaughn inquired as to a plan for replacing the Ward 4 Councilperson. President Nenadovich advised that Council had 30 days to find a replacement. He was going to place an ad in the Neighborhood News that week. Then he would determine when to hold the interviews and inform Council of those dates in writing.

Clmn Vaughn moved to adjourn the Caucus Meeting and Clmn Dudley seconded. His motion stood approved by 6 Yes (Vaughn, Dudley, Donahue, Nenadovich, Blake, Tagliarini) votes.
