

**COUNCIL CAUCUS MEETING MINUTES
CITY OF GARFIELD HEIGHTS, OHIO
Thursday, March 26, 2020**

(Note: This meeting was conducted by teleconference.)

Council President Matt Burke called the Caucus Meeting to order at 6:30 p.m.

Councilman Vaughn moved to excuse Councilman Dudley from the Caucus Meeting and his motion stood approved by 6 Yes (Vaughn, Donahue, Nenadovich, Davis, Blake, Burke) and 1 Absent (Dudley) vote.

President Burke moved to suspend the Invocation, Pledge of Allegiance, Written Communications to Council, Committee Reports and Reports from Directors except for the Report of the Mayor. His motion stood approved by 6 Yes (Burke, Vaughn, Donahue, Nenadovich, Davis, Blake) and 1 Absent (Dudley) votes.
