

**COUNCIL CAUCUS MEETING MINUTES
CITY OF GARFIELD HEIGHTS, OHIO
Monday, April 13, 2020**

(Note: This meeting was conducted by teleconference.)

Council President Matt Burke called the Caucus Meeting to order at 6:31 p.m.
