

COUNCIL CAUCUS MEETING MINUTES

CITY OF GARFIELD HEIGHTS, OHIO

Monday, June 22, 2020

Council President Pro Tem Michael Nenadovich called the Caucus Meeting to order at 6:30 p.m.

President Nenadovich moved to accept the Caucus Minutes of June 8, 2020 as written, Clwn Davis seconded and his motion stood approved by 6 Yes (Nenadovich, Davis, Blake, Vaughn, Dudley, Donahue) and 1 Absent (Burke) votes.
