## REPORTS OF THE MAYOR AND DIRECTORS:

PRESIDENT BURKE: We will move on to the Reports of the Mayor and the Directors. Mayor, do you have a report for us this evening?

MAYOR VIC COLLOVA: Thank you, Mr. Chairman. Yes, I do. Once again, tonight we have the honor of congratulating another Garfield Heights sports team for an outstanding season. The Eighth Grade Boys School Basketball Team finished the 2018-2019 basketball season with a 13-3 overall record. They also were the Champions of the Greater Cleveland Conference

Tournament. Their 2-year record for the middle school was 30-6. Great record. The boys also excelled in their classroom as student athletes. One of those young athletes, Tommy Ben, has one of the highest GPAs in the school with a 4.2. Their academic and athletic work has made Garfield Heights proud. I want to thank Coach Bill Ritter, all the players and assistant coaches for a job well done. Coach, if you would, I'd like you to come forward with your team and introduce them to Council and to all the people here. Athletes, all up front.

Coach Bill Ritter. I would like to thank the Mayor and Council very much for the honor and privilege of having our basketball team come to the meeting to be honored tonight. It's my privilege and blessing to have been able to coach these young men over the past two years. As the Mayor mentioned we have some outstanding student athletes to go along with their athletic ability. I know Coach Sonny Johnson at the high school's looking forward to them becoming high school players. This is exactly the type of individual that he wants. Scholar athletes-not just athletes.

If I could call the guys off. If you would just step forward when you hear your name? Jalen Davis, Stevie Cornwell, Tommy Ben, Ermayer Mitchell, Anthony Golubski, Mila McGaugh, Noah Werman and Antonio Cavaya. I'd also like to thank Principal Sauer, Principal Glazer and our new athletic director for coming out to support us. I don't want to keep any more of your time. I'm sorry. I saw a mom over there saying what's going on. I missed Antonio Bonnie. I would love to thank the parents for all their support. You always hear about the negative things going down. Mandree Reet, step up, lad. Did I miss somebody? I'm sorry. You hear a lot of negative things about parental interference with the program, but this was nothing but support. When you put all those components together, you have an opportunity to win a championship. Thank you very much for having us here. If we could have a little hand for the boys?

PRESIDENT BURKE: And as always, I would just like to say that while you don't have to stay for the Council Meeting, if you want to, you are more than welcome to, but if you wish to leave now, you can. Please do it quietly so that we can still run our meeting. Thank you.

MAYOR VIC COLLOVA: Thank you very much. You really make Garfield Heights proud. We're happy.

## PRESIDENT BURKE: OK, Mayor.

MAYOR VIC COLLOVA: OK. We're going to continue on. I once again want to remind everybody about the Alzheimer's Association and Dementia Meeting they are having here. Again, Alzheimer's is not normal aging. It's a disease of the brain that causes problems with memory, thinking and behavior. Please join us on Tuesday, February $26^{\text {th }}$ from 7 o'clock to 8 o'clock right here at the Garfield Heights Civic Center for this important meeting. This is a disease that has really taken hold of us in the last few years and it's something that all families will be dealing with so if you get an opportunity I think it's a great place to go next Thursday.

I also wanted to take a moment to talk to Council and the residents. I had the opportunity about a week or two ago to attend a meeting for the Garfield Heights School Teachers. They were basically principals and some of the assistant principals. It was about emergency responses. It was really something. It was about a four-hour program. In the past when we
were young we used to think about the teachers had to make sure they taught the kids what to do, they had to keep track of the children and they had to be a part of their education. Today some of their duties are a little different. They were talking about what a teacher has to do if an active shooter's in the school. That's the kind of teaching they get. It was unbelievable when it came right down to what should a teacher do if they're between the gunman and the student. That's how serious some of this stuff is. I can't be any more proud of the Garfield Heights teachers. They do a phenomenal job with the resources they have. They really do phenomenal things. The thought that they have to go through training because of active shooters out there, it's scary what this world has become. I give them all the credit in the world. They went through a great program. Unfortunately, I'm sorry that I don't have the instructor's name, but she did a phenomenal job. It was really a good job.

The next thing I wanted to say was at the last Council Meeting Ordinance 5-2019 talked about fire gear that was being purchased for the Fire Department. I mistakenly said that the fire gear was being paid for by a grant. I was informed that that grant actually ran out a couple years ago and that cost to the city would be $\$ 24,000.00$. So I wanted to make sure I corrected that statement.

With that, I'm going to get into tonight's legislation. Ordinance 11-2019 authorizing the city to increase its rates for emergency medical services.

Resolution 2 allows us to apply for a grant for fire training and equipment. Resolution 3 allows us to apply for a Community Recycling Grant. Resolution 4 appointing Doug (Doug, I hope I don't get your name wrong. I see it all the time and it's just Doug. Is he here? I know you by Doug.) The reason that I selected him for this position is because he's at every meeting anyway. He's very familiar with what's going on in the city. He really is an active participant in the city. So I really endorse Doug. Is it Piascik? Piascik. I was close. You have to spell it different. I'll be able to pronounce it. Anyways I would certainly like Doug's support for this position.

With that, I want to wish everybody a Happy Valentine's Day. Mr. Chairman, you have my report.

PRESIDENT BURKE: Thank you, Mayor. Does anybody have any questions for Mayor Collova on his report this evening? Yes, Mr. Vaughn.

CLMN VAUGHN: Mayor, with Mr. Piascik taking Elizabeth Jackson's place did you want to inform everybody why we're doing this?

MAYOR VIC COLLOVA: Elizabeth Jackson has done a great job. She's been on the Planning Commission for many years--long before I was the Mayor. She has done an outstanding job. She had a knee operation about a year ago. She got an infection in that knee and they had to re-operate on it. She is in some pretty bad shape. She can't even walk. She has to use a walker or a wheelchair. As much as she would have liked to have spent more time with the Planning Commission, she felt it was her duty to back out. Now believe me at which time she would heal up we would certainly look to put her back somewhere in the city because she's done a great job.

CLMN VAUGHN: Thank you.
PRESIDENT BURKE: Are there any other questions for Mayor Collova this evening? If there are none, we will move on to our Law Director Tim Riley. Tim, do you have a report for us this evening?

LAW DIRECTOR TIM RILEY: No report this evening.
PRESIDENT BURKE: Thank you, Tim. We'll move on to our Fire Chief, Chief Strope. Do you have a report for us this evening?

FIRE CHIEF KENNETH STROPE: No report this evening either.
PRESIDENT BURKE: Thank you, Chief. We'll move on to our Police Chief. Chief Byrne, do you have a report for us this evening?

POLICE CHIEF ROBERT BYRNE: Yes, I do, Mr. Chairman. It's just a reminder that the $21^{\text {st }}$ of February from 9:00-11:00 a.m. we will host Coffee with a Cop at the Rockside Road McDonald's and everybody is invited. That concludes my report.

PRESIDENT BURKE: Thank you. Does anyone have any questions for Chief Byrne this evening? There are none. We'll move on to our Service Director Mr. Tim McLaughlin. Tim, do you have a report for us?

SERVICE DIRECTOR TIMOTHY MCLAUGHLIN: Yes, I do. Thank you, Mr. President. Just to touch on the rubbish with the taking the cans in. Since the middle of October there's been 166 tickets written. There is 1,267 final warnings. So the next one these people are going to get a ticket. It's amazing that some people have already. We have seven houses that's already gotten four tickets and they still continue to leave them out so evidently they have enough money to keep paying the tickets. We're still working at it. Some weeks you think you did better and other weeks it seems like we go right back to where we were so we will keep on enforcing it.

There is some discussion about water breaks in the city. Just from January $2^{\text {nd }}$ to the present, we have had 26 water breaks. Some of them were pretty big. There are a few around here right now. There's one that everybody is talking about or calling about on Langton and $106^{\text {th }}$. It was marked by the utilities. All the flags are around it. We've called Cleveland repeatedly because it actually was a fire hydrant break. They can't just shut off the fire hydrant because the way it was done, you'd shut off the water to the houses. Cleveland is so busy that they are contracting out water breaks so we called the company and they are actually working in our city already. They're on Warner Road with a big water break on the bottom of it. They said that hopefully they would get there some time this week. They didn't give us a guarantee but it's the best we could do. Since the beginning of October, we've had 57 breaks. Like the cold we had for a few days and some will pop up all over. It seems like a lot but as long as I've been here, we've had times where we had 160 of them in a winter. I think some of the streets that they replaced water lines on has helped us out in the last three/four years. Anyhow, there's been a lot of people talking about water breaks and we're not by ourselves. Every city's in this problem.

The last thing I have is the new asphalt trailer came in two weeks ago. We've already used it three times in the last 10 days. We take the cold patch and heat it and put it down. It was out today for a while. Whenever we have time until the hot patch plants open. One of them's opening next week, but I don't think I'm going to pay $\$ 143.00 /$ ton. It's a convenience thing. That's why they're opening this early, but I think until the regular ones all open together we will continue to buy the cold patch, heat it and put it down. That truck is only being used right now weather permitting.

The last last thing. The leaf program doesn't go through the whole winter. I mean we've had some calls wanting to know when we're coming to get their leaves. Those trucks are long gone, put away. We stayed out three weeks longer this year and I would think in February if you didn't rake your leaves before that, I mean so. They can put them in a bag or a can but we're not coming back out to get them. I think next October will probably be the next time we'll be picking up leaves. With that, you have my report.

PRESIDENT BURKE: Thank you, Tim. Does anybody have any questions for Mr. McLaughlin on his report tonight? There are none, we'll move on to our Parks and Rec Director, Robert Dobies. Bob, do you have a report for us this evening?

PARKS AND RECREATION DIRECTOR BOB DOBIES: Yes, I do. Mr. President and Council Members, good evening. Just a couple things this evening. Our futsal, our indoor soccer program, is into a second week of games and remains very popular.

Thinking spring, the t-ball information will be up on the Website shortly. Registration will be from March $1^{\text {st }}$ through April $1^{\text {st. }}$. As in the past, we will send out letters and flyers to families of past participants. This is a co-ed program for those who are five-seven years old. Always looking for managers for t-ball, If anybody's intersested please call Kevin Koelliker at (216) 2446077 or you can contact the Rec Office.

Last, as we come to the end of another skating season, our Annual Melt-the-Ice Tournament is this weekend, Friday, Saturday and Sunday. Come out and see our talented youth play along with teams from surrounding areas and out of State competition. This year we will have a special guest on Saturday, 2/16, from about 12:00-1:00 p.m. He might be there a little bit longer. We will have a visit from Sully. Sully is the mascot for out own Cleveland Monster champion hockey team. Along with this year's tournament, 2019 marks 50 years our municipal hockey program has been in existence. This along with 50 years of figure skating marks another landmark in our city, which we can all be proud of. I'd like to say thank you to all our team members, coaches and volunteer parents and our Booster Club along with my staff for making these traditions a reality. Any other questions, please call the Rec Center. Thank you. That concludes my report.

PRESIDENT BURKE: Thank you, Mr. Dobies. Does anyone have any questions for Mr. Dobies on his report this evening? If there are none, we will move on to our Finance Director, Ms. Barb Biro. Barb, do you have a report for us?

FINANCE DIRECTOR BARB BIRO: No, I do not, Mr. President.

PRESIDENT BURKE: We'll move on to our City Engineer, Mr. David Krock. Dave, do you have a report for us?

CITY ENGINEER DAVID KROCK: Thanks, Mr. Chairman, I have no report this evening.
PRESIDENT BURKE: Thanks, Dave. Let's go to our Social Services Director, Kathy RushParsson. Kathy, do you have a report for us this evening?

SOCIAL SERVICES DIRECTOR KATHY RUSH-PARSSON: Yes, I do. Thank you. Just a quick reminder that we are currently taking appointments for the free tax preparation service offered by the AARP volunteers. Appointments are filling up fast. They are available on Fridays from 9:15 a.m. until 2:30 p.m. weekly, ending on April $5^{\text {th }}$. You must bring a valid form of ID and last year's tax return. If you would like to make an appointment or if you need more information, please call the Senior Center. That's all I have.

PRESIDENT BURKE: OK. Does anybody have any questions for Kathy on her report this evening? If not, we'll move on to our Economic Development Director, Noreen Kuban. Noreen, do you have a report for us this evening?

ECONOMIC DEVELOPMENT DIRECTOR NOREEN KUBAN: Yes, I do. Thank you, Mr. President. I urge Council to support Resolution 3-2019. We want to apply for the 2019 Community Recycling Awareness Grant. We can receive up to $\$ 5,000.00$ in reimbursement without a city match. The purpose of the program is to educate residents about recycling awareness. We will also hold two recycling events this year. The first on May $4^{\text {th }}$. The second on September $21^{\text {st }}$.

I mentioned this at the last Council Meeting that our next Help for Homeowners event program will be on Wednesday, February $27^{\text {th }}$ from 5:30 p.m. to 7:30 p.m. I urge people to contact Neighborhood Housing Services in advance. Ask for Stephanie at (216) 205-4468.

This is something I just became aware of and I wanted to share it with residents. Northeast Ohio Sewer District has some programs for individuals who need assistance.
$\diamond$ The first is the Homestead Rate Program and residents can get a reduced quarterly sewer rate. It is for customers 65 years or older or anyone who is under 65 and totally disabled. The person must own their house and you can get a discount.
$\diamond$ The second one is the Summer Sprinkling Program. I know many people know about this. That operates form May $1^{\text {st }}$ through September $30^{\text {th }}$. For both those programs, the phone number is (216) 881-8247.
$\diamond$ There's also two additional programs. One is the Wastewater Affordability Program. Customers who have income levels below 200\% of the Poverty Level can get reduced rates for their sewer bill.
$\diamond$ Finally, there's a Plumbing and Sewer Repair Program. It's an emergency service line replacement. You must be a homeowner as well and must meet the income guidelines. For those two programs, the direct phone number is (216) 901-1222. That concludes my report.

Our rates have been probably the lowest for the last five years. If you have ever needed them, believe me, it's worth the ride. I vote Yes.

I agree with Mr. Suster's saying this will not cost the residents anything more. So if you're a resident they basically going to take whatever your insurance company pays, you know. I knocked on her window. She didnd come to the window. I knocked on the shutter. She still dkndt come but I could hear somebody walking and he dog barking. Then a little while later a little boy come out, no coat on, didnđ seem like he had no shoes, running around and picked up this big bag of trash. I told him lôn tired of you all throwing this trash out. There ainđ nobody throwing no trash out here and he went on back in the house. Now what an be done about it?

MAYOR VIC COLLOVA: Ms. Whitmore, Mr. President, if I may?
PRESIDENT BURKE: Sure.
MAYOR VIC COLLOVA: I didn't mark down your address. What's your address again?
MS. WHITMORE: My address? 13154 Forestdale Drive.
MAYOR VIC COLLOVA: They're the house next door to you?
MS. WHITMORE: Her's is 13150. Victoria Priest.
MAYOR VIC COLLOVA: 13150?
MS. WHITMORE: Yes.
MAYOR VIC COLLOVA: 13150?
MS. WHITMORE: I had called on Mr. Dudley late on a Sunday. I know I sounded harsh on the phone, but I wanted him to come out there before they cleaned it up, but they still haven't cleaned it up. I'm sick of it.

MAYOR VIC COLLOVA: Let me ask you this? I would love to catch them in the act or at least have one of our people visually see them throw it out.

## MAYOR VIC COLLOVA: All right?

CLMN GLENN: Mrs. Whitmore. I'd like to ask you a question. I looked at the one picture there. It looks like the trash bags are next to your driveway? I don't see no doorway there. So they have to really go out of their way to put that trash there?

MS. WHITMORE: No. They throwing out the bedroom windows upstairs.
CLMN GLENN: Upstairs. Down on your property. It's coming on your property. This is intentionally done maliciously.

MS. WHITMORE: Yes.
CLMN GLENN: That's all I have to say, Mr. President.
PRESIDENT BURKE: Thank you, Gene.
CLMN DUDLEY: Mr. Chairman.
PRESIDENT BURKE: Mr. Dudley.
CLMN DUDLEY: I wanted to mention you said you drove by and didn't get a chance to stop there. I didn't get a chance to stop Sunday. If you go by you could see how where the items is positioned and stuff like. That is obviously, Mayor, that is not coming out by like the back door so somebody can go around from that point if nobody don't see it. Ms. Whitmore been here for a long time.

CLERK: This involves the business of Council in the legislative function; any other problems should be directly dealt with by the department involved. This area of the agenda shall be limited to legislative business, Ward business, lack of attention toward problems, etc.
