REPORT OF THE MAYOR:

MAYOR VIC COLLOVA thanked the Council President and began his report by stating that the city hall had been closed since Wednesday, March 18, 2020 and all services have been closed except for emergencies because of the Coronavirus. The Senior Center would be open every day. Everybody that came in to get meals at the Civic Center would be having them delivered to their house four days/week. The Center would continue with the two Food Banks. Some Directors would be coming in. The Service Department would not be patching potholes, etc. because they would only be able to perform essential duties. This arrangement would continue the following week. He might bring back staff on April 6, 2020, but was not certain.

Because of the Coronavirus crisis, the city could stand to lose 25%-30% of its income tax revenue. The Mayor would have to make numerous decisions. He might have to impose monthly furlough days/layoffs for the employees.

As for the evening's legislation, Mayor Collova encouraged Council to support both Ordinance 31-2020 regarding the purchase of a fire engine and Ordinance 32-2020 concerning leasing a dark fiber network. That was the end of his report.

PRESIDENT BURKE thanked the Mayor and asked whether anyone had any questions for the Mayor on his report. There were none.
