When the unit comes in, they will give us the loaner to use until the tank we're buying is in, but it's on a first come first serve basis. I did talk to the sales rep that we'd been dealing with and he did tell me that shortly thereafter if it's not available when we get the unit they will have a loaner for us. That's the best I can give you right now.
