We had negotiations with all the Unions this year with regard to their contracts and we had a wage reopener with AFSCME regarding just wages with them. We negotiated. We couldnd come to a resolution. We went to a Factfinder back on April 20th. The Factfinder gave us his report, which is attached to the legislation, indicating that he recommended a wage increase of 48 cents/hour or 2% whichever the employee wanted. This was pretty much what we offered--very close--so we feel this is a very fair agreement and we have one week to either affirm or reject this report. So that is why I scheduled a Special Meeting for tonight. I would ask Councilos support in affirming this report and accepting it. Thank you.

PRESIDENT BURKE: OK. Does anybody have any questions for Mr. Riley at this time?

MAYOR VIC COLLOVA: Mr. Chairman, if I can ask. Mr. Riley, explain to them that they are going to try and approve it on Wednesday.

LAW DIRECTOR TIM RILEY: Yeah and the Union is meeting on Wednesday. They had the same amount of time as we do--one week--to approve/reject it. Thank you.
