Glenn from tonighton meeting, all in favor signify by saying Yea. Any opposed?

PRESIDENT BURKE: OK. They are excused but they may show up. It looks like there may have been a little lack of communication here with the way the agenda was printed up. Mayor, do you have a report for us this evening? On anything?

PRESIDENT BURKE: Is there anyone out there wishing to speak on tonights agenda? If there isns, then we will move on to Ordinances and Resolutions beginning with Ordinance 53-2018. Will the Clerk please read the title?

ORDINANCE NO. 53-2018

AN EMERGENCY ORDINANCE AMENDING SECTION 13 OF THE GARFIELD HEIGHTS CITY CHARTER PROHIBITING FIRST TERM COUNCIL MEMBERS FROM HOLDING THE OFFICE OF PRESIDENT PRO TEM, AND PROVIDING FOR THE SUBMISSION OF SAID AMENDMENT TO THE ELECTORATE OF THE CITY OF GARFIELD HEIGHTS, OHIO Moved by NENADOVICH to CONSIDER BY TITLE:

PRESIDENT BURKE: You dong want to consider by title?

CLMN GLENN: No, Mr. President, if I may have the floor?

PRESIDENT BURKE: Sure.

CLMN GLENN: I want to say, first of all, this is not an emergency. We got plenty of time. In like to have a three reading on this here.

PRESIDENT BURKE: OK. We are getting ready to vote on that, Gene.

CLMN GLENN: OK.

PRESIDENT BURKE: I just wanted to make sure I heard you properly.

CLMN GLENN: I said Nay.

PRESIDENT BURKE: OK.

CLMN GLENN: Before I vote here, I would like to make some comments here. First of all, this is not an emergency ordinance. We have plenty of time. Ites been a practice of this organization that everythinges an emergency. Everything is not an emergency. This is a self-motivated ordinance for the protection of Council members here. Thates why lem saying Nay. Thank you.

PRESIDENT BURKE: Let the record show that Clmn Suster has joined us. Mr. Suster, we got started at 6:00 p.m. We are on Ordinance number 53-2018. It is your time to vote.

CLMN DUDLEY: Before I vote, I just received all of these Friday and prior to Friday, I didnot even get a copy of what they had even fully discussed. For medical reasons I wasnot able to make the last meeting of the Charter Review. So I wasnot even be privileged to the information till I received them in front of me Friday. I donot have too much trouble with it because I think that you should go that extra year to give yourself a chance to be seasoned before you actually take a Council Presidentos seat. So with that I vote Yes.

CLMN GLENN: Before I vote, I have not received the Minutes of the Charter Review Meeting. We get minutes of every other meeting. Why not now? Why didnot we have the most important minutes? Every four years we have not got the minutes of the meeting. I requested the minutes of the meeting. I vote No and I request the Three Reading Rule, please.

CLMN SUSTER: I have to agree with Mr. Glenn. On any of these ordinances that deal with the Charter changes we have not received any minutes and we haven that time to study them.

CLMN DUDLEY: Before I vote, what I would have to concur with several of them is that I didnq have the minutes. When I talked to several members of the Charter Review, I preferred the suggestion they made as to how the Council President would be selected by the people by adding additional two names of the individuals running and another section you will have all individuals that were running for that election. The people would be able to pick one of those at the bottom. The ones who make it should you pick an individual who did not make it, then it would go to the next highest count. I believe that would be the best process of selecting a Council President than what is going on right now because I do not agree on the process as handled now their election of Council President. With that Ign going to have to vote No.

The normal Councilmen that endorse these ordinances have self-motivation not to have their name on there. This is for protection of a City Councilman and a Pro Tem. I vote Nay. Thank you.

CLMN DUDLEY: Once again, before I vote, five years for someone to be able to run for City Council. I would have been more in tune with maybe two years. Five years is a long time for someone to have to sit and they maybe have good qualifications to advance the city further. To me that will be a loss of possibly good candidates in the near future. With that, I may have to vote No.

We should be allowed to serve on boards such as the Mayor and anybody else would. Thereos just too many restrictions placed on us that we cannot serve on school boards outside of the city and not so much as that but we cannot serve as any board where thereos additional income. With that, I vote Yes.

CLMN GLENN: Before I vote, there is nothing on these ordinances saying what the Charter was prior to this to what it is going to be. So if the electorate is going to vote on something they should know what they que changing it from to. They have their choice. They should be informed. They are not informed, but they que going to be voting on it. I vote Nay.

It gives them an additional time for them to be able to read and kind of make the changes and suggestions and all to give us an opportunity to go and hear these suggestions long before this timeframe getting caught up in last minute as it is today. I would have to say. With that, I vote Yes.

CLMN GLENN: Before I vote, there is no emergency here. We had four years since our last Charter Review. We had plenty of time. If there is an emergency in time restraints, it is because ther Law Department didn put it in a timely fashion. I put that on the Law Department--not putting this out in a timely fashion so we have the minutes of the Charter Review and let the electorate be informed on what they going to vote on. We as Council do not even have the minutes of the Charter Review. I vote Nay.

CLMN NENADOVICH: Before I vote, the Charter Review Committee those were not recorded

notes, were they?

LAW DIRECTOR TIM RILEY: No, those were handwritten notes. I think where the confusion seems to be coming in is that when you have a Council committee, Council has to get the minutes and approve them. This is a separate committee. Any Councilman could have asked for those minutes at any time, but they dong need to be approved by Council. So the minutes were available for weeks now. I dong know what the problem is with the minutes. They could have been reviewed. The meetings were open to the Councilmen too. I think a lot of Council people went to the meetings. So I think the confusion is that Charter Review is not a committee of Council. Ites a city committee required by the Charter. So the City Council doesng approve those minutes. OK? Thank you.

CLMN NENADOVICH: Before I vote, I have one other comment. There is no difference between this package and any other package we get on our regular Council Meetings. We receive the packet either Thursday or Friday. Then we have a chance to come in Monday and ask about them, but there is no difference between being this and any other meeting that we have where we are pre-informed weeks and weeks ahead of time. This is standard operating procedure for Council since laye been on for 10 years and prior to that. I dong know where the controversy comes in for notes because we dong get the notes from the regular meetings until Thursday or Friday before that and we have three days to approve it, to take a look at it and if we have any questions, Monday I usually come in and talk to Tim or the Chief or Barb. I decide my vote on the weekend but it confirms it on Monday. With that, I vote Yes.

CLMN GLENN: Before I vote, I want to say that we should be informed of everything soing on. I do not know there is a Charter Review that made recommendations. I do not know the total amount of those recommendations. There has been Members of this Council that took it upon them to review it and they did not inform me as a Councilperson as what was accepted and what was.

MAYOR VIC COLLOVA: Mr. Chairman, if I may.

PRESIDENT BURKE: Yes.

MAYOR VIC COLLOVA: When Geneos finished.

CLMN GLENN: I vote No on this here. I am very adamant about this here that this is trying to be pushed through Council at a fast rate without knowing what going on. I vote Nay.

PRESIDENT BURKE: Mayor, do you want to respond now or wait till after?

MAYOR VIC COLLOVA: Id wait till after the vote.

CLMN SUSTER: Before I vote, I would just like to say with the people that were on the Charter Review Committee, half of them werend there half of the time. People were put on in the middle that didnd know what was going on. I just had a hard time with this whole procedure this time. It was been on Council for a pretty long time and attended a lot of Charter Reviews. The way this one went, I did not agree with 90% of it. Ion going along with some of these things only for the simple fact that maybe they picked up one or two good items. Like I say, half of the people werend there. I think ites a real shame. If you make a commitment that you want to be on a committee and you want to represent the people of your Ward, then somebody asks you and you say Yes, younge telling them that you will be at every one of those meetings and I made a comment and I had a young lady say, Boy, I wish we would have known that before we talked about this.+So how can they make decisions and now we want to put it on the people? With that, Ion vote Yes.

The last Charter Review Committee Meeting I personally invited all of Council to attend that meeting so that the committee would have an opportunity to explain to Council why they chose that. Now if the Council members did not go to that, it certainly isnq the committeeqs fault, the Law Departmentqs fault or everybody elseqs fault, it is the Councilpersonqs fault.

The other thing is, understand this. That if, in fact, this is not an emergency and we can wait three months for the readings there will not be enough time to get it on the Board of Electionsq ballot this time so it is an emergency and I need you to note that before we go any further. Thank you.

PRESIDENT BURKE: Thank you, Mayor. Let on to Ordinance 59-2018. Will the Clerk please read the title?
