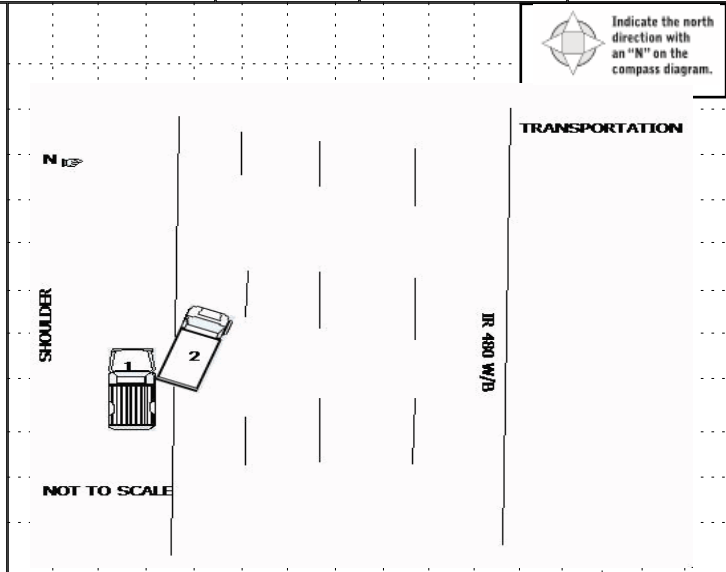

UNIT 1, ODOT SAFETY VEHICLE, WAS OPERATING W/ B WITH YELLOW FLASHERS ACTIVATED, IN LEFT SHOULDER IN ORDER TO PASS TO RESPOND TO AN ACCIDENT ON IR-480 BRIDGE. UNIT 2 WAS IN LEFT SHOULDER AHEAD OF UNIT 1 PASSING STOPPED TRAFFIC. UNIT 2 THEN WENT TO ENTER BACK INTO LANE 4 WHEN UNIT 1 APPROACHED FROM REAR. UNIT 2 TO TURNED INTO LANE 4 AND LEFT REAR OF TRUCK SWUNG IN THE SHOULDER WHEN UNIT 1 PASSED UNIT 2 AND UNIT 1 PASSENGER MIRROR STRUCK OR WAS STRUCK BY UNIT 2

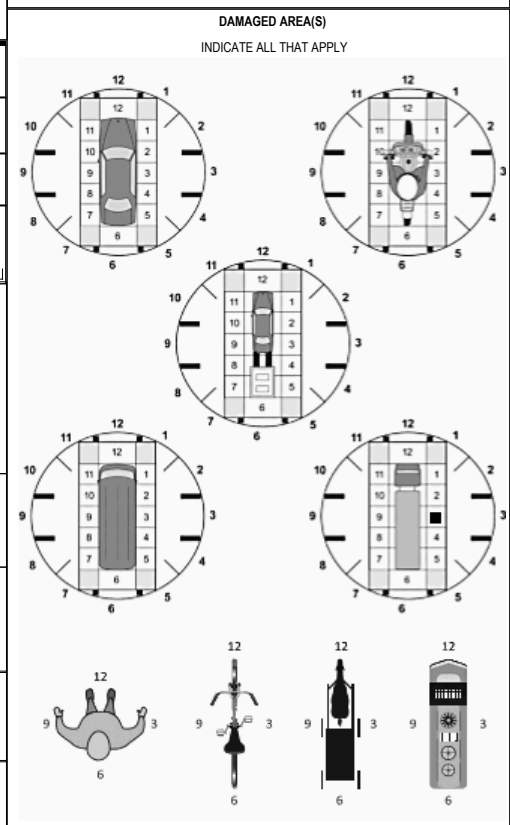

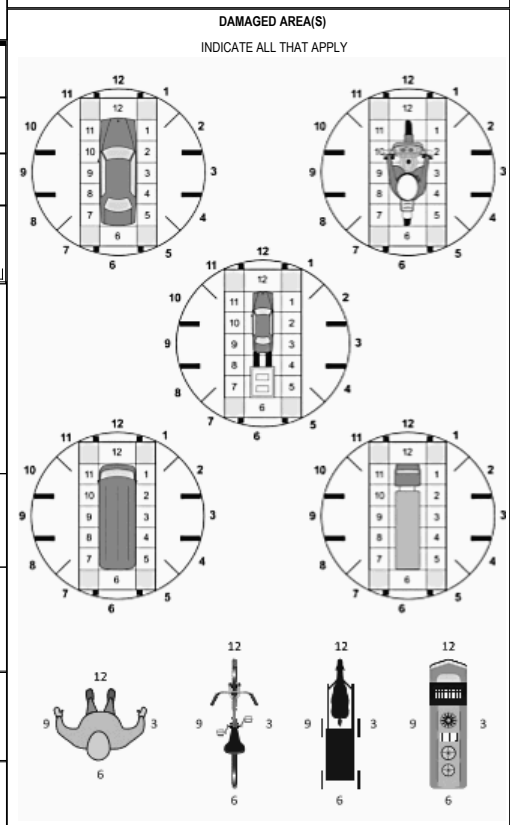
