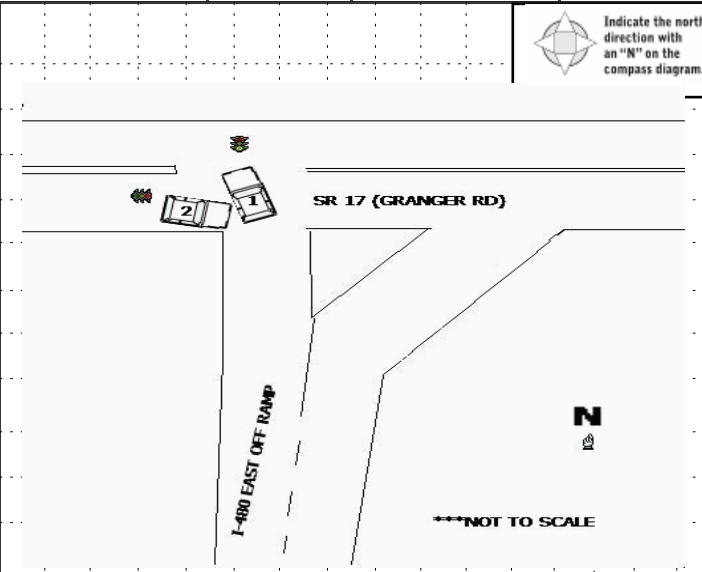

UNIT 1 HAD A GREEN SIGNAL AND WAS BEGINNING TO MAKE A LEFT TURN ONTO SR 17 (GRANGER RD) FROM THE I-480 EAST OFF RAMP. UNIT 2 WAS TRAVELING E/B ON SR 17 AND RAN THE RED LIGHT AT THE I-480 E OFF RAMP AND STRUCK THE LEFT REAR AREA OF UNIT 1. UNIT 2 THEN FLED THE AREA. A WITNESS DESCRIBED UNIT 2 AS A ROYAL BLUE CHEVY IMPALA WITH AN OHIO TEMP. TAG THAT WAS MISSING ALL THE DIGITS. DRIVER OF UNIT 2 WAS DESCRIBED AS A BLACK MALE WITH DREAD LOCKS. UNIT 2 WAS SAID TO HAVE DAMAGE TO FRONT LEFT AND DRIVER'S SIDE OF VEHICLE INCLUDING MIRROR

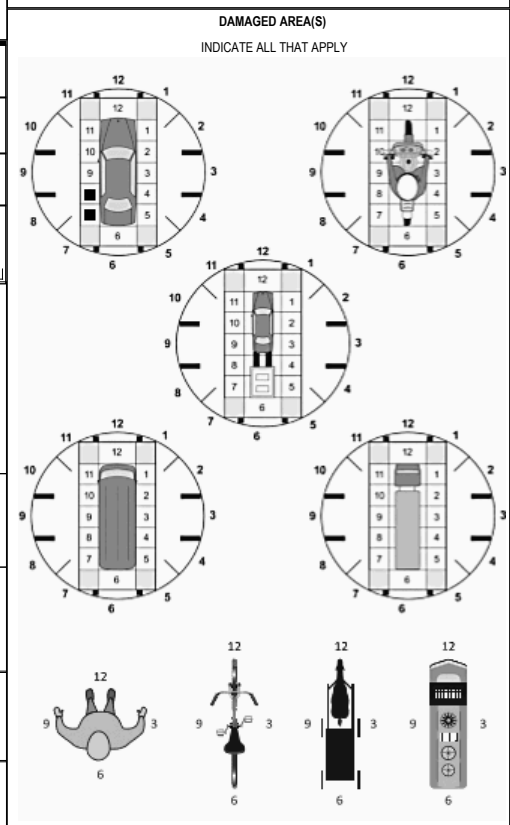
