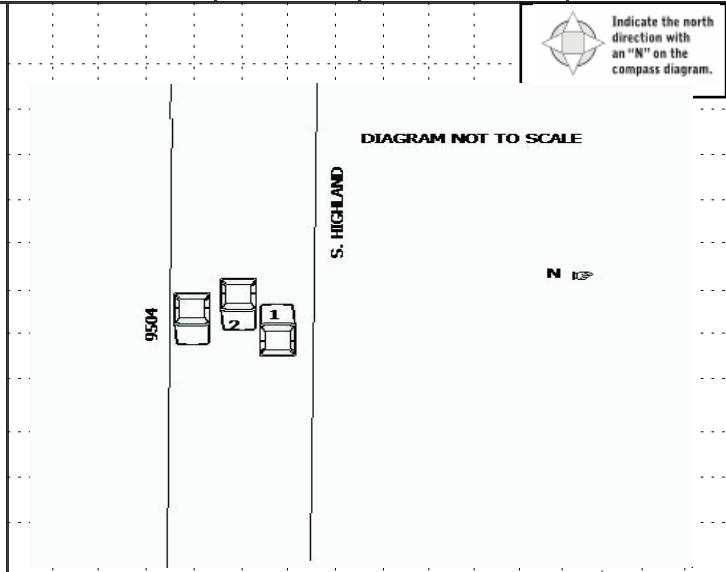

DRIVER OF UNIT #2 STATED SHE WAS TRAVELING EASTBOUND ON S. HIGHLAND WHEN SHE ATTEMPTED TO PASS A PARKED CAR AT THE SAME TIME UNIT #1 WAS ALSO TRAVELING PAST THE SAME PARKED CAR AND THE DRIVER'S MIRROR OF UNIT #2 STRUCK THE MIRROR OF UNIT #2.

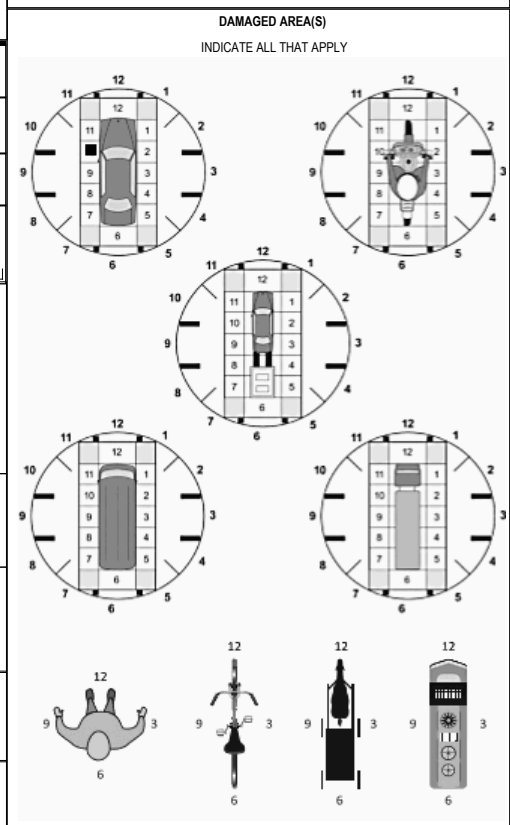
