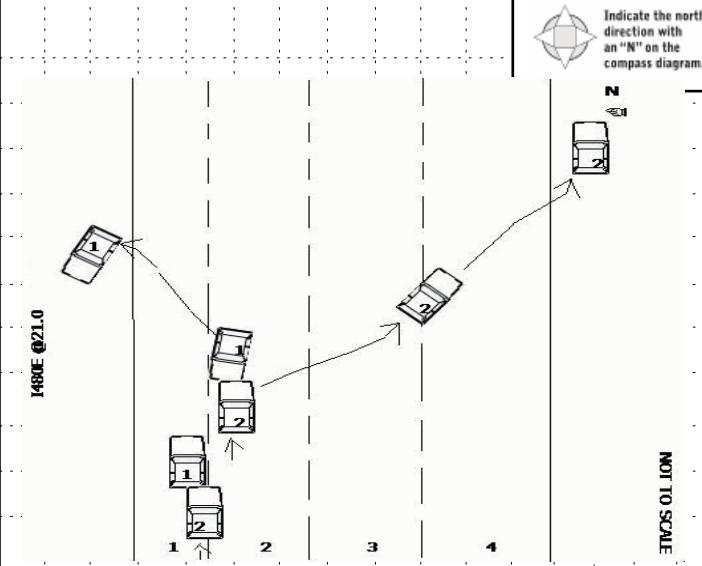

NARRATIVE  
 UNIT 1 WAS TRAVELING EAST ON I480 APPROACHING MP 21 IN THE HIGH SPEED LANE. UNIT 2 WAS TRAVELING BEHIND UNIT 1. OPERATOR OF UNIT 1 STATED THEY WERE STRUCK FROM THE LEFT REAR, BEGAN TO SPIN OUT OF CONTROL AND THEN WAS STRUCK AGAIN IN THE LEFT FRONT. OPERATOR OF UNIT 2 STATED THAT UNIT 1 BEGAN TO SPIN OUT CAUSING UNIT 2 TO STRIKE UNIT 1 IN LEFT REAR WITH THE RIGHT FRONT OF UNIT 2. NEITHER OPERATOR HAD THEIR INSURANCE INFORMATION.

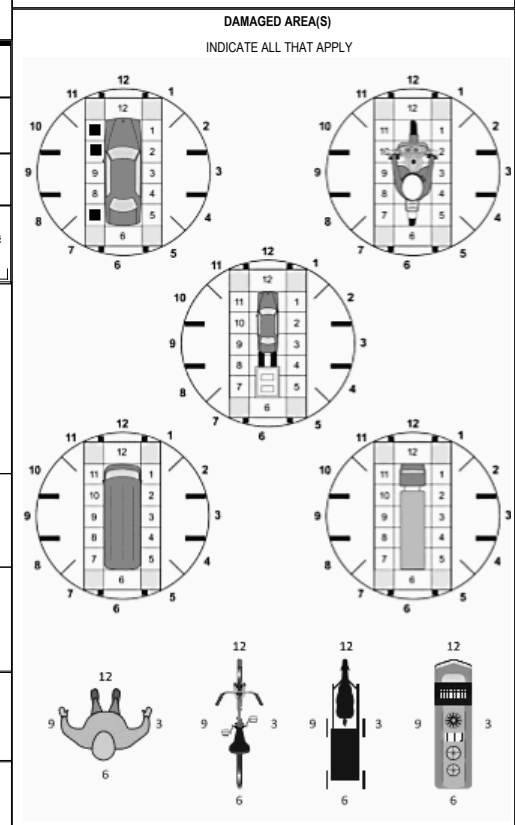
