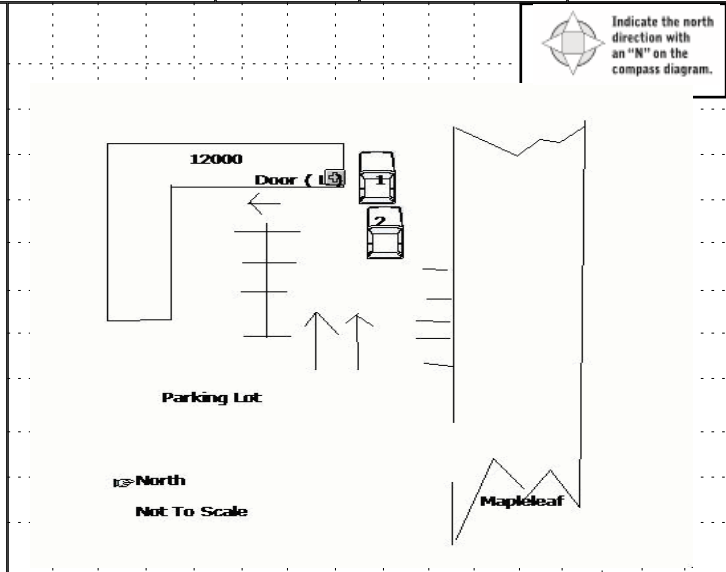

AS A RESULT, THE REAR OF UNIT # 1 COLLIDED WITH THE FRONT OF UNIT # 2. UNIT # 1 LEFT THE SCENE BACKING IN A EASTERN DIRECTION AGAINST THE LANES OF TRAVEL AND PROCEEDED OUT OF THE PARKING LOT ONTO MAPLELEAF. UNIT # 2 CAME TO THE GHPD STATION TO FILE A REPORT.

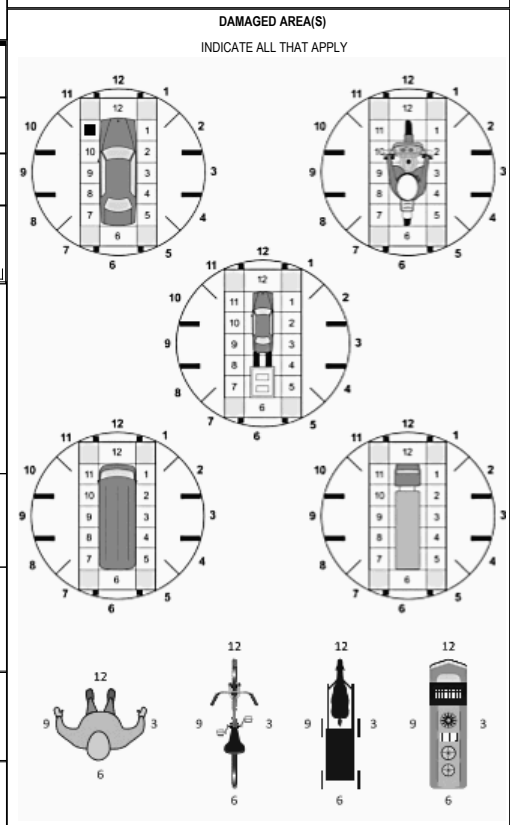
