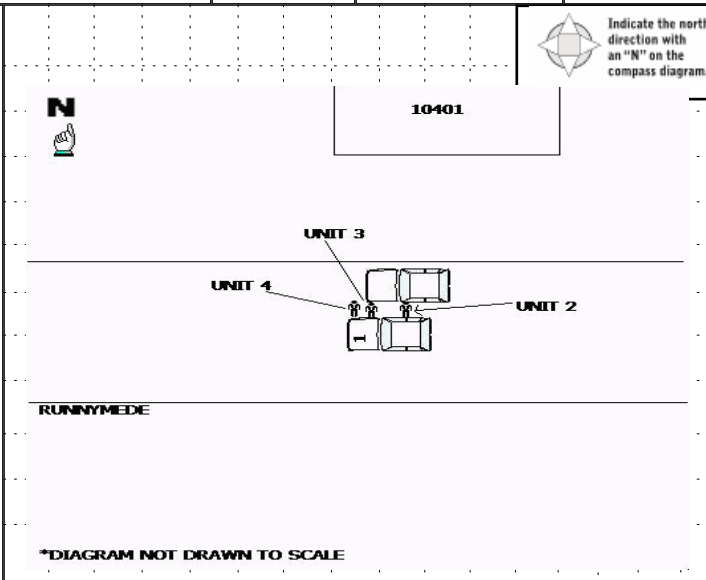

 THE OPERATOR OF UNIT 1 STATED HE WAS TRAVELING W/B ON RUNNYMEDE APPROACHING 10401 WHERE MULTIPLE PEDESTRIANS WERE STANDING IN THE STREET NEAR A VEHICLE PARKED ON THE WRONG SIDE OF THE STREET. #1 HONKED ITS HORN SEVERAL TIMES TO ALERT THE PEDESTRIANS TO CLEAR THE LANE OF TRAVEL AND CLOSE VEHICLE DOORS OPEN IN TRAFFIC. AS THE PEDESTRIANS SLOWLY CLEARED THE LANE OF TRAVEL, #1 CAUTIOUSLY CONTINUED FORWARD PAST THE PEDESTRIANS. THE OPERATOR OF #1 DID NOT BELIEVE HE HAD STRUCK ANY PEDESTRIANS.

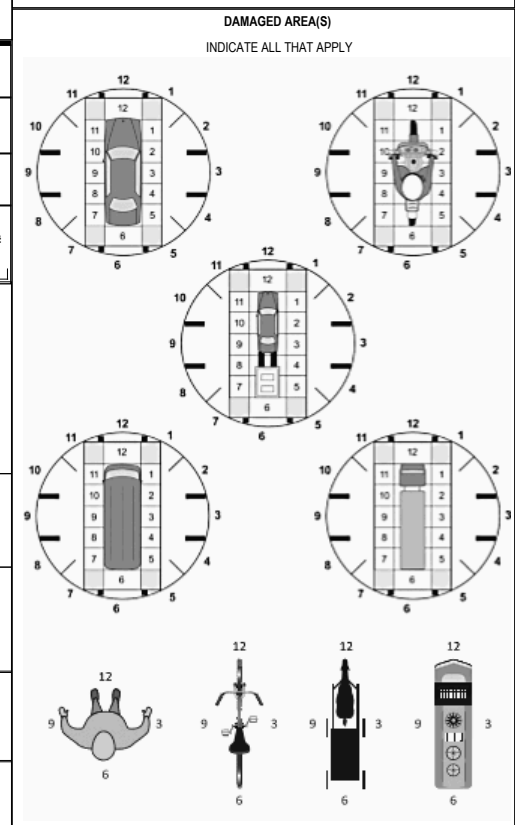

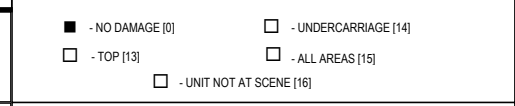
