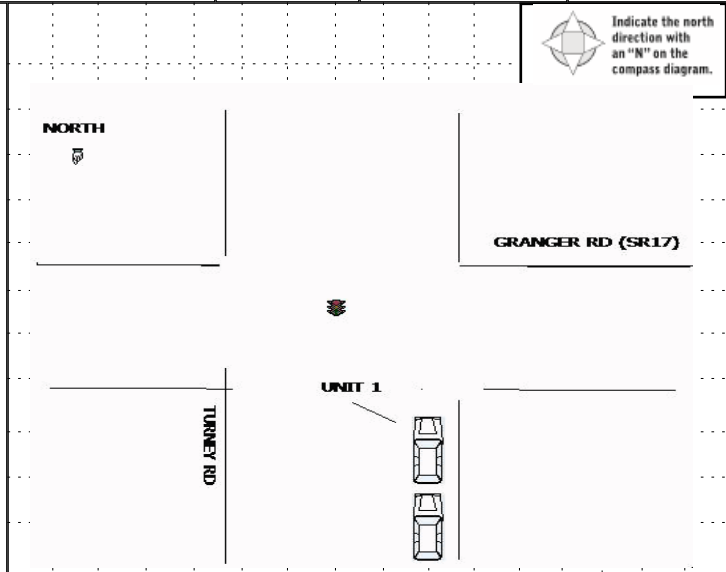

UNIT 1 WAS TRAVELING ON TURNEY SOUTH BOUND AND STOPPED AT THE TRAFFIC SIGNAL WITH A RED LIGHT IN THE CURB LANE. UNIT 2 WAS TRAVELING DIRECTLY BEHIND UNIT 1 IN THE SAME LANE AND FAILED TO STOP STRIKING UNIT 1. THE DRIVER OF UNIT 2 APPEARED TO BE IMPAIRED SEE INCIDENT REPORT. UNIT 2 STATED AN UNIDENTIFIED AUTO STRUCK HER FROM BEHIND PUSHING HER INTO UNIT 1, OFFICERS FOUND NO EVIDENCE OF UNIT 2 BEING STRUCK FROM BEHIND.
