NARRATIVE UNIT ONE WAS TRAVELING EASTBOUND ON IR 480 EAST, IN THE SLOW SPEED LANE (LANE #1). AS UNIT ONE WAS PREPARING TO EXIT AT THE TRANSPORTATION BOULEVARD EXIT RAMP, THE DRIVER OBSERVED UNIT TWO SWERVING IN AND OUT OF TRAFFIC, VIA HER REAR VIEW MIRROR. AS UNIT ONE WAS SLOWING DOWN TO EXIT THE FREEWAY, UNIT TWO FAILED TO PROVIDE ASSURED CLEAR DISTANCE AHEAD AND STRUCK UNIT ONE IN THE REAR. 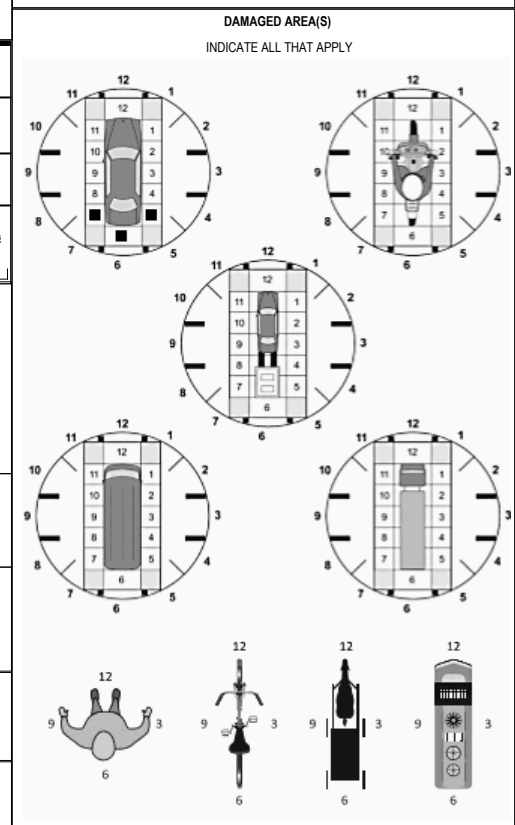

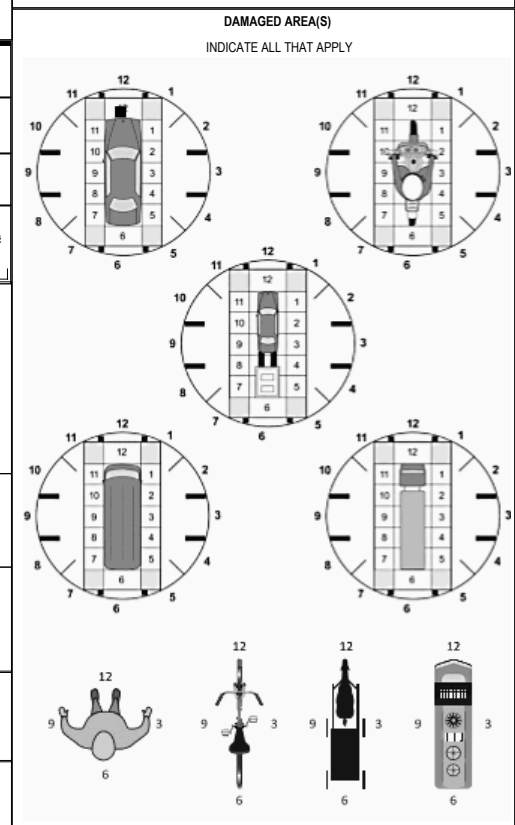
