WHILE TRAVELING IN THE TURN LANE, UNIT 1 ATTEMPTED TO DRIVE INTO HER LANE AND STRUCK THE RIGHT SIDE OF UNIT 2. BOTH UNITS PULLED OFF THE ROADWAY AND EXCHANGED INFO AND THEN LEFT THE SCENE. 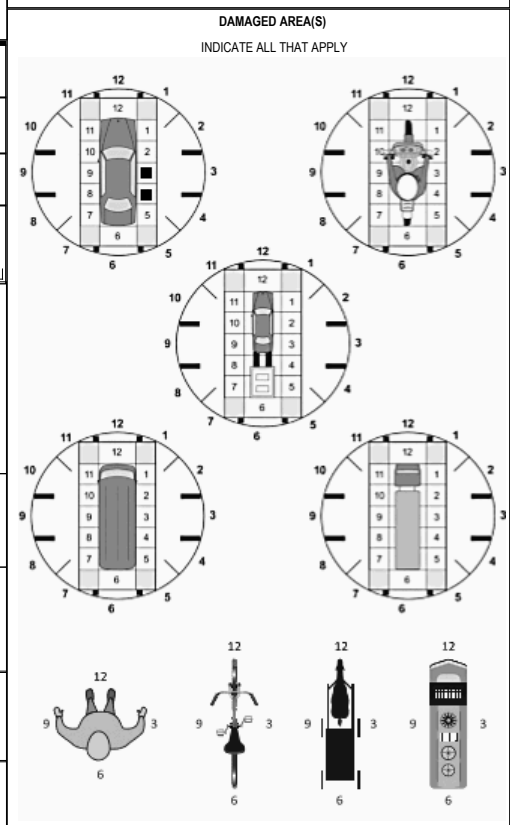
