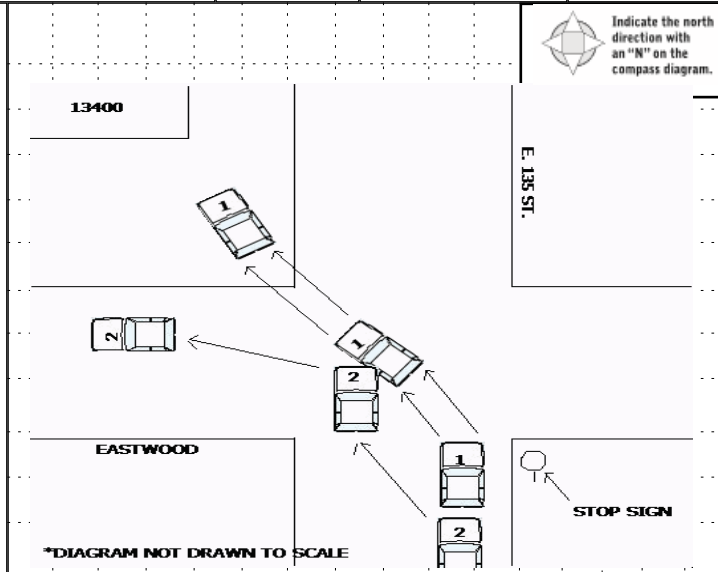

 UNIT 1 WAS STOPPED FOR THE STOP SIGN ON N/B E . 135 AT EASTWOOD PREPARING TO TURN LEFT.
 UNIT 2 WAS STOPPED DIRECTLY BEHIND UNIT 1. AS UNIT 1 PROCEEDED INTO THE INTERSECTION TO MAKE ITS LEFT TURN UNIT 2 PROCEEDED TO PULL PASS UNIT 1 TO THE LEFT CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE CENTER LEFT SIDE. THE IMPACT FROM UNIT 2 CAUSED UNIT 1 TO TRAVEL OUT OF THE ROADWAY INTO THE YARD OF 13400 EASTWOOD WHERE IT CAME TO REST. UNIT 2 FAILED TO STOP AND FLED THE SCENE OF THE CRASH.
