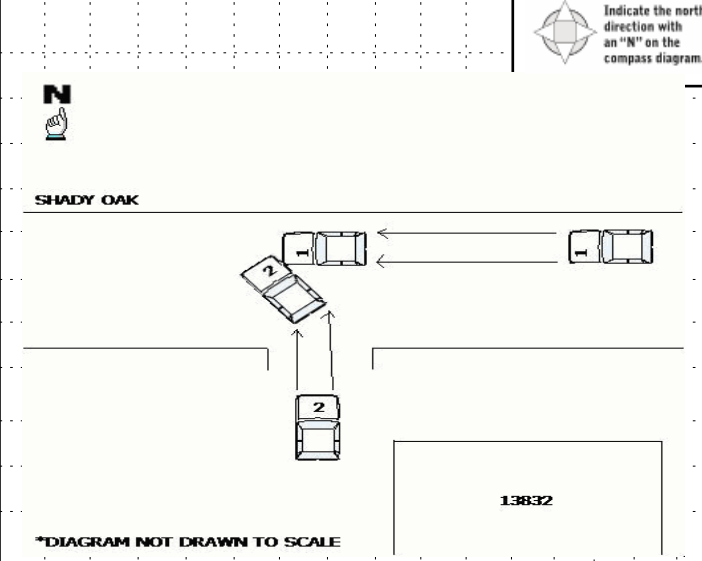

UNIT 2 FAILED TO YIELD TO UNIT 1 WHEN TURNING LEFT CAUSING UNIT 1 TO STRIKE UNIT 2 IN THE RIGHT FRONT. THE OPERATOR OF UNIT 2 ATTEMPTED TO GATHER CRASH INFORMATION FROM THE OPERATOR OF UNIT 1. AT THIS TIME UNIT 1 FLED THE SCENE WITHOUT EXCHANGING PROPER INFORMATION.

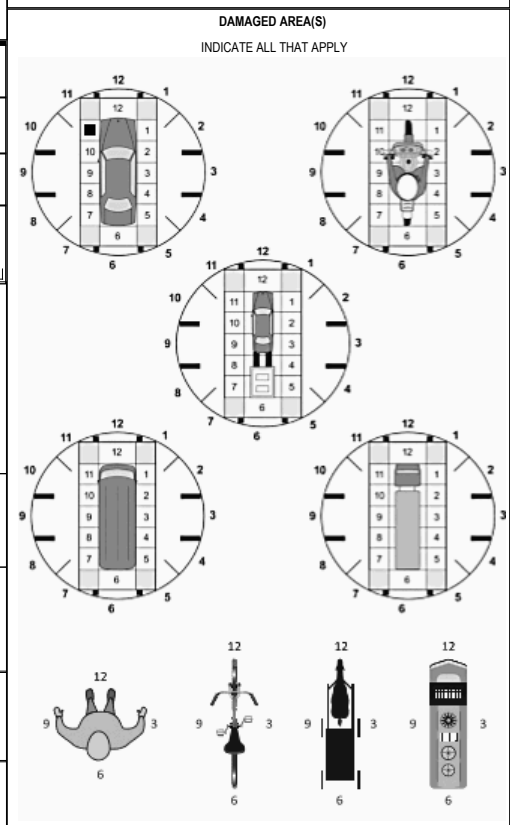

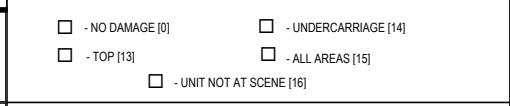

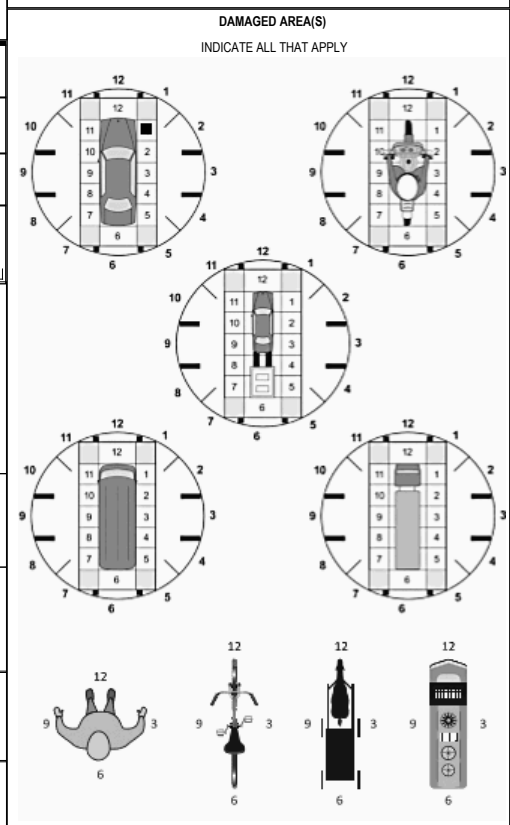
