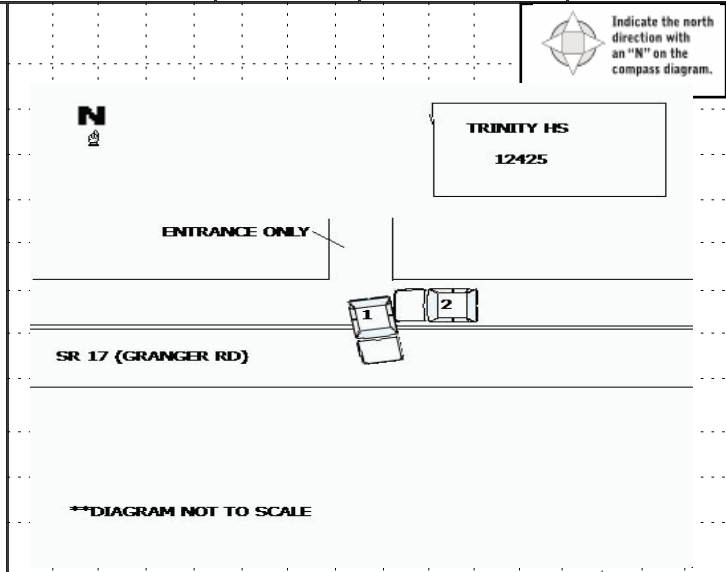

THIS OFFICER SPOKE WITH DRIVER OF UNIT 2 AT THE GRANGER RD ENTRANCE TO MARYMOUNT HOSPITAL. SHE STATED UNIT 2 WAS TRAVELING W/B ON SR 17 (GRANGER RD). UNIT 1 WAS TRAVELING S/B THROUGH THE N/B ENTRANCE TO TRINITY HS (124 25 GRANGER) PARKING LOT AND DROVE ONTO GRANGER RD IN AN ATTEMPT TO TURN LEFT AND FAILED TO YIELD TO UNIT 2. UNIT 2 STRUCK THE LEFT REAR AREA OF UNIT 1. UNIT 1 THEN LEFT THE SCENE AFTER THE CRASH. SHE COMPLAINED OF A POSSIBLE ARM INJURY.

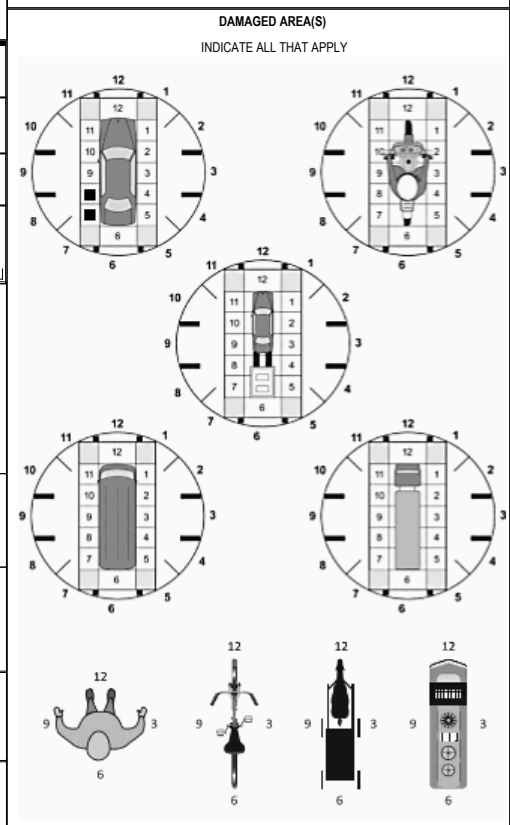
