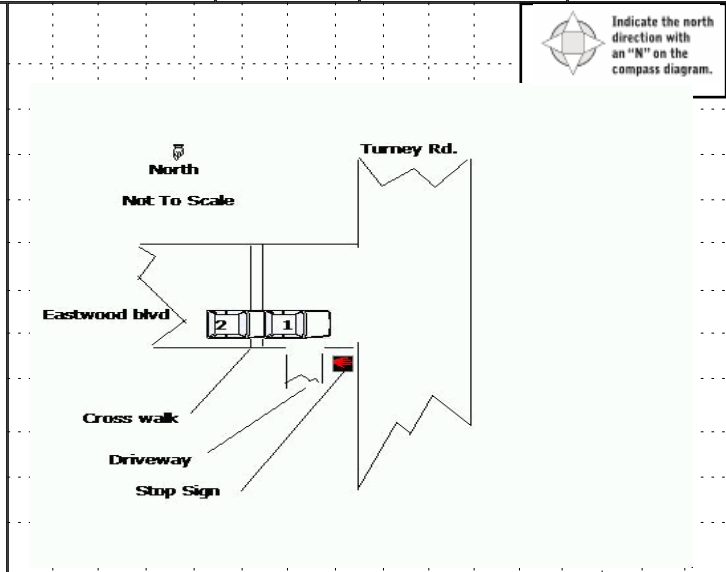

NARRATIVE

UNIT # 1 WAS TRAVELING WEST ON EASTWOOD BLVD STOPPED NEAR THE INTERSECTION WITH TURNEY RD. UNIT # 2 WAS DIRECTLY BEHIND UNIT # 1. UNIT # 1 BACKED IN A EASTWARD DIRECTION AWAY FROM THE INTERSECTION. AS A RESULT, THE REAR OF UNIT # 1 COLLIDED WITH THE FRONT OF UNIT # 2. BOTH UNITS WERE PARKED ON EASTWOOD BLVD. FACING WEST UPON ARRIVAL.

NOTE: DRIVER OF UNIT # 1 STATED, PULLED TO FAR INTO THE INTERSECTION AND DID NOT SEE OTHER VEHICLE. REAR WINDOW COVERED WITH SHEET OF PLASTIC.
