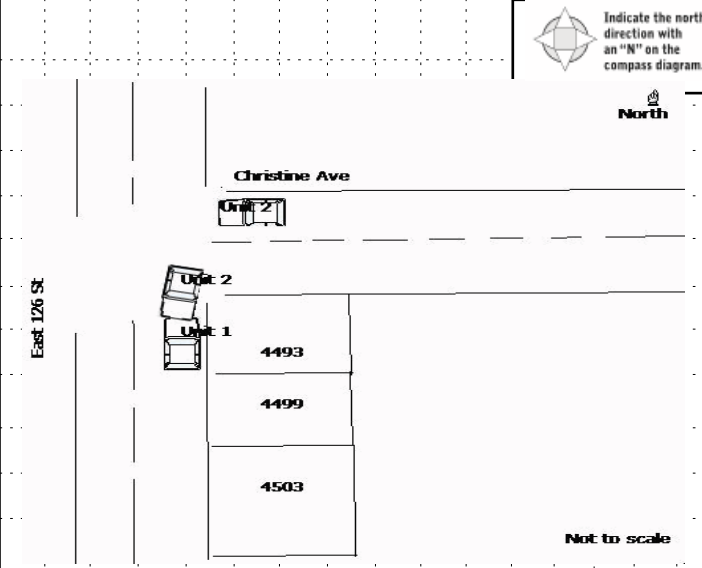

UNIT 1 MADE A SOUTHBOUND TURN ONTO EAST 126 STREET WHEN IT STRUCK UNIT 1 HEAD ON. UNIT 2 STATED THAT AN UNKNOWN VEHICLE HIT HER VEHICLE WHICH CAUSED HER TO HIT UNIT 1. AFTER SPEAKING TO THE OWNER OF UNIT 1 WHO WITNESSED THE ACCIDENT. SHE STATED THAT UNIT 2 STRUCK HER VEHICLE HEAD ON AND SHE DID NOT SEE ANYONE STRIKING UNIT 2.

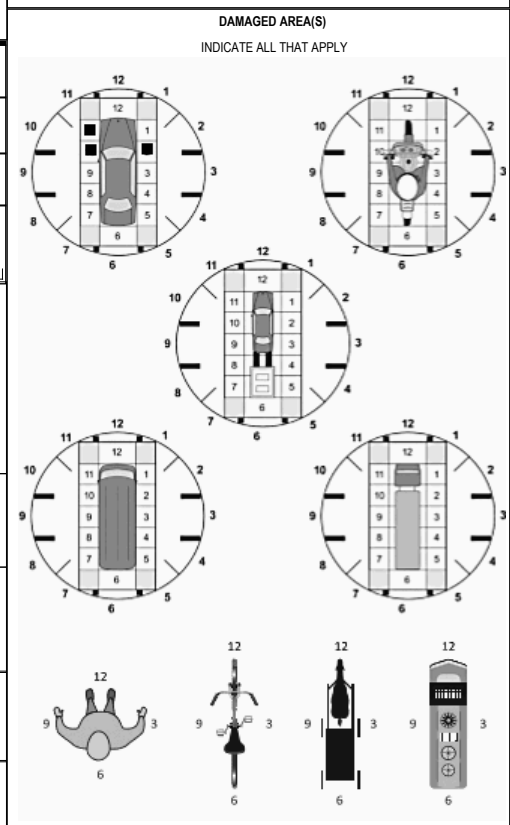

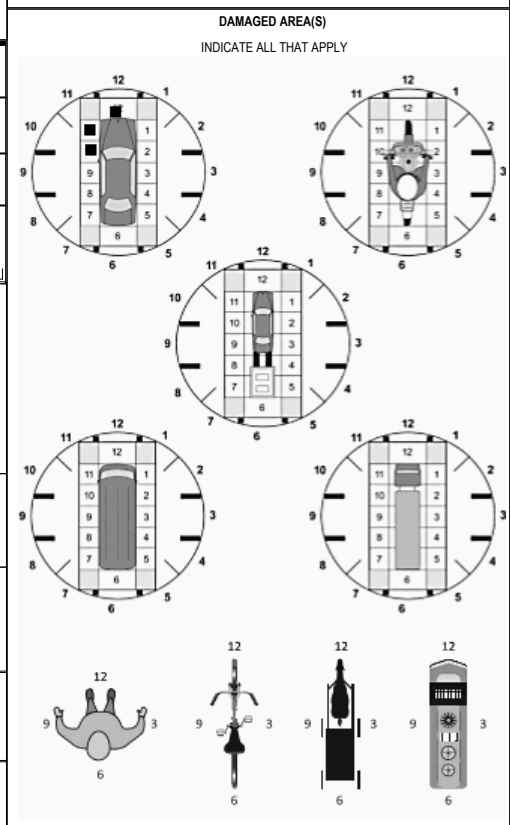
