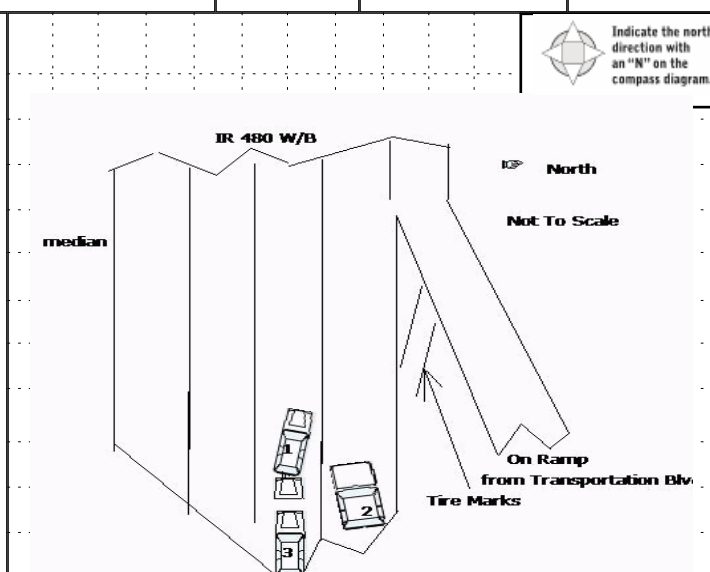

UNIT # 3 WAS DIRECTLY BEHIND UNIT # 1. THE RIGHT SIDE OF UNIT # 1 AND THE LEFT SIDE OF UNIT # 2 COLLIDED. BOTH VEHICLES TRAVELED OFF THE RIGHT SIDE OF THE ROADWAY AND BACK ONTO THE ON RAMP FROM TRANSPORTATION BLVD. UNIT # 3 WAS STRUCK BY PIECES OF DEBRIS FROM THE COLLISION. 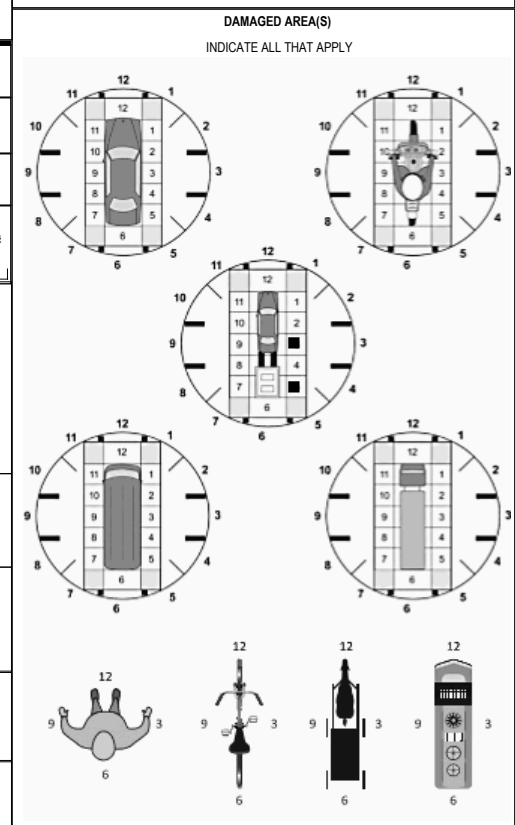

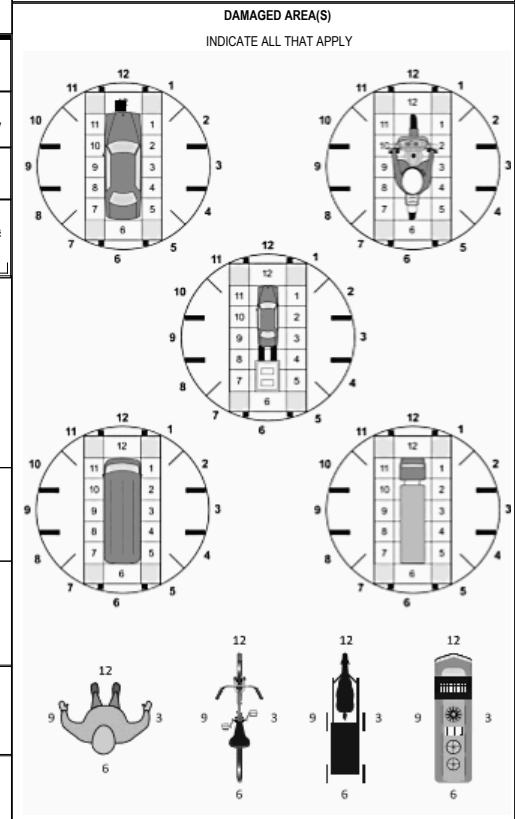
