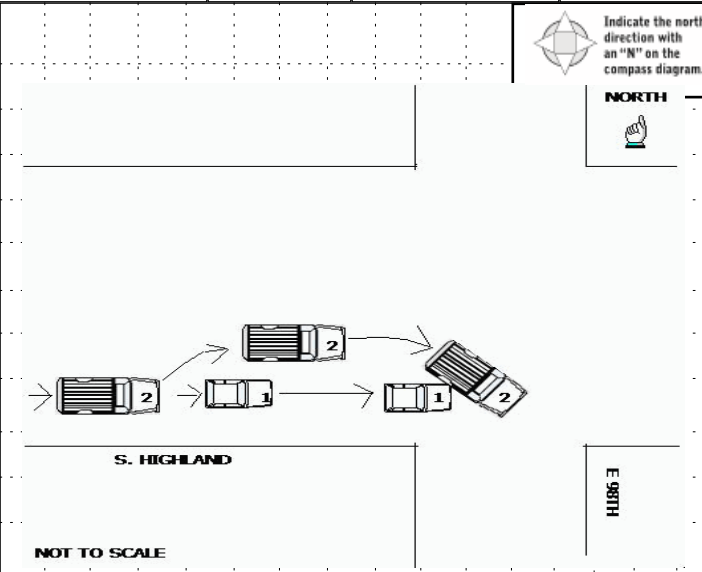

UNIT 2 THEN BEGAN TO MAKE A SOUTHBOUND TURN ONTO E.98TH FROM THE WESTBOUND LANES CAUSING UNIT 1 TO STRIKE THE RIGHT SIDE OF UNIT 2 WITH THE LEFT FRONT OF UNIT 1.

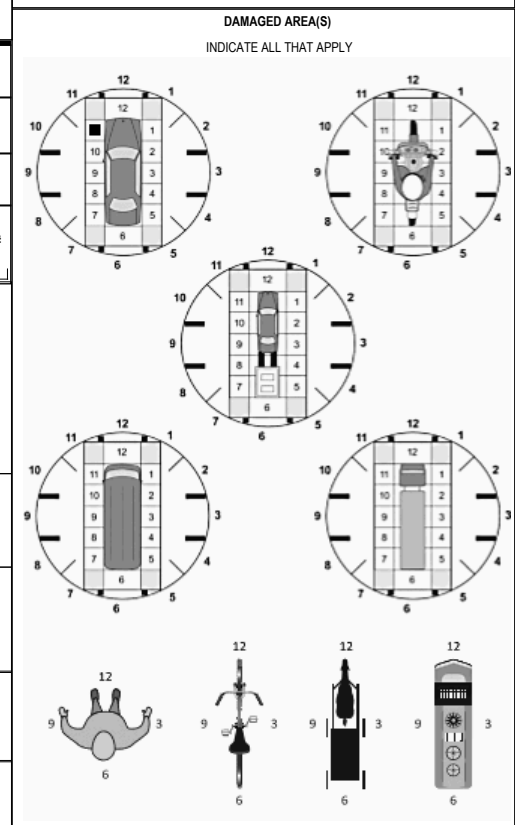

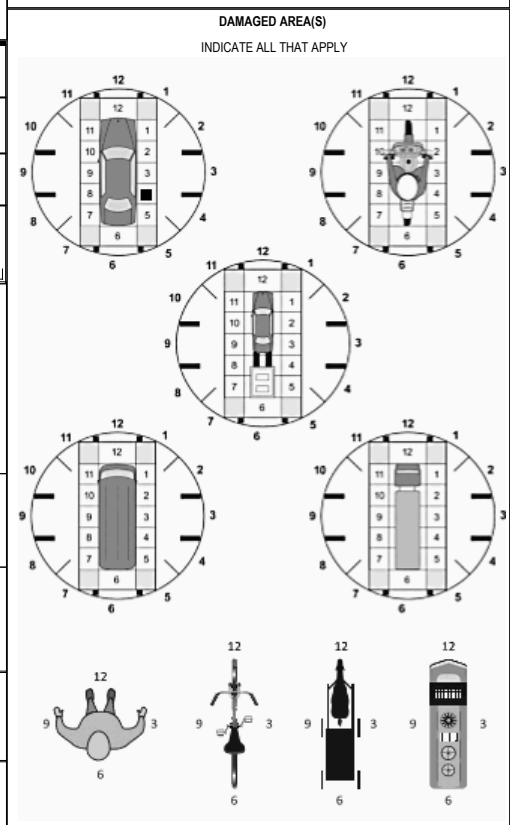
