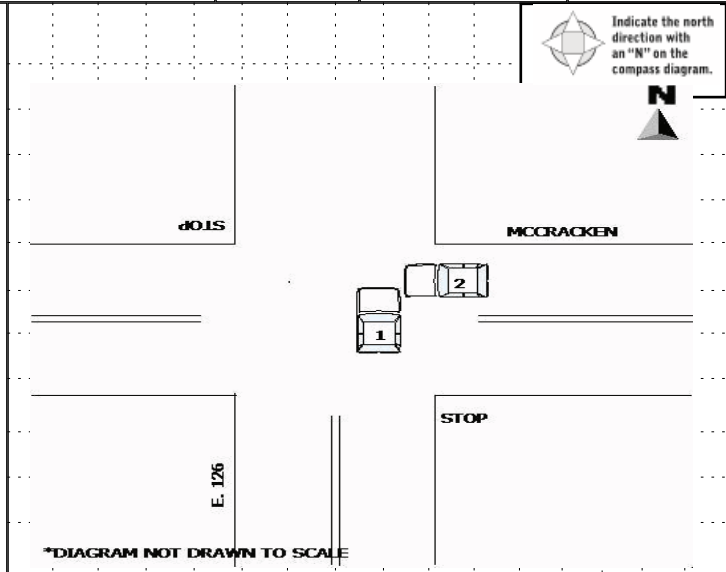

UNIT 1 WAS TRAVELING N/B ON EAST 126TH AND STOPPED AT THE STOP SIGN AT MCCRACKEN RD INTERSECTION. UNIT 1 PROCEEDED N/B THROUGH THE INTERSECTION AND FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING W/B ON MCCRACKEN RD. UNIT 2 STRUCK THE RIGHT FRONT OF UNIT 1. UNIT 2 HAD NO TRAFFIC CONTROL DEVICE AND HAD RIGHT OF WAY AT INTERSECTION. BOTH VEHICLES THEN PULLED INTO A NEARBY PARKING LOT. NO INJURIES WERE REPORTED.

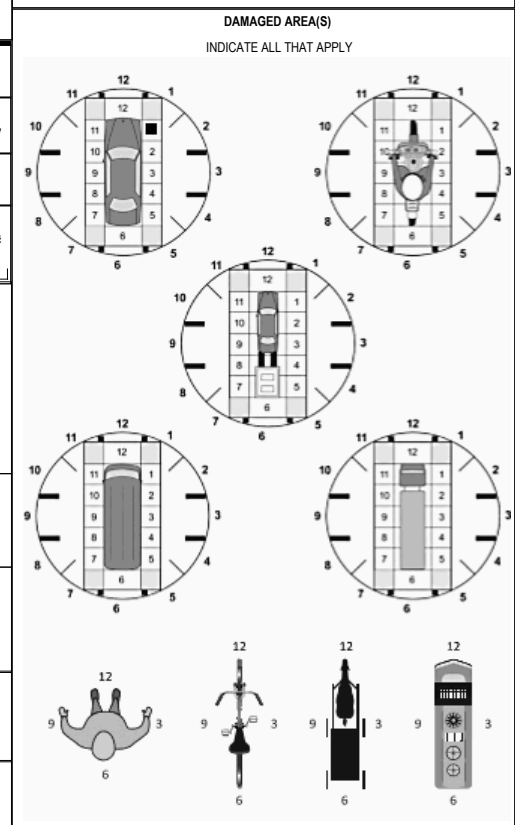
