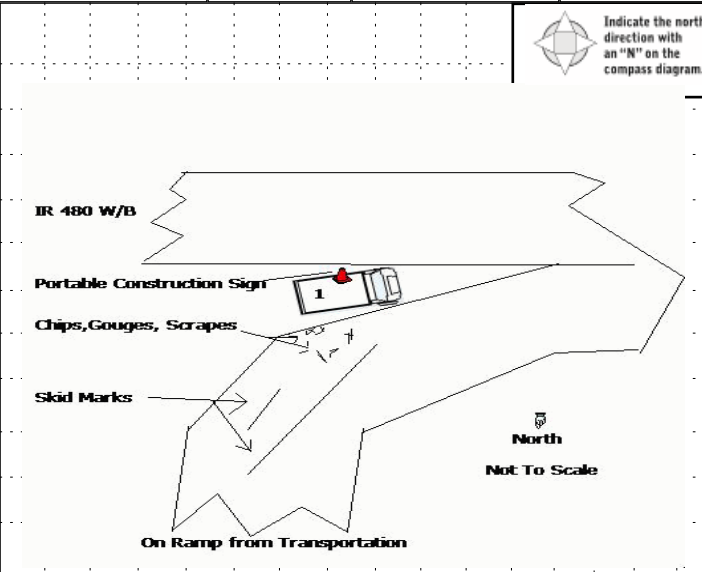

AS A RESULT, UNIT # 1 TRAVELED OFF THE LEFT SIDE OF THE ON RAMP, DAMAGING THE ROADWAY, THEN OVER TURNED ONTO ITS LEFT SIDE. WHILE OVERTURNING UNIT # 1 COLLIDED WITH A PORTABLE TRAFFIC SIGN.
