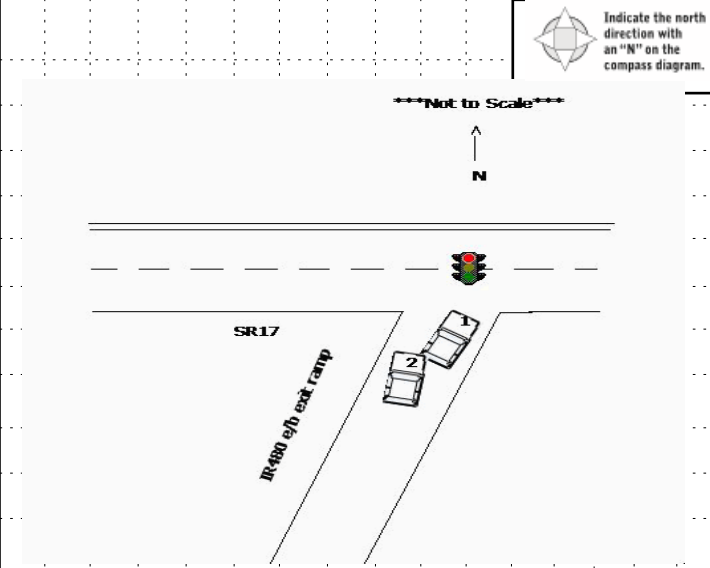

NARRATIVE  
 DRIVER OF UNIT #1 EXITED IR480 E/B AT SR17. WHILE STOPPED AT THE RED LIGHT ON THE EXIT RAMP, THE DRIVER STATED HE PULLED FORWARD AND STOPPED AGAIN TO CHECK FOR TRAFFIC ON SR17. WHEN HE STOPPED JUST BEFORE SR17, HIS VEHICLE WAS REAR-ENDED BY UNIT #2. DRIVER OF UNIT #2 STATED SHE WAS STOPPED DIRECTLY BEHIND UNIT #1 ON THE EXIT RAMP. ACCORDING TO HER, UNIT #1 PULLED FORWARD AND SHE FOLLOWED NOT REALIZING HE WAS GOING TO STOP AGAIN TO CHECK FOR TRAFFIC. THUS, HER VEHICLE STRUCK UNIT #1.

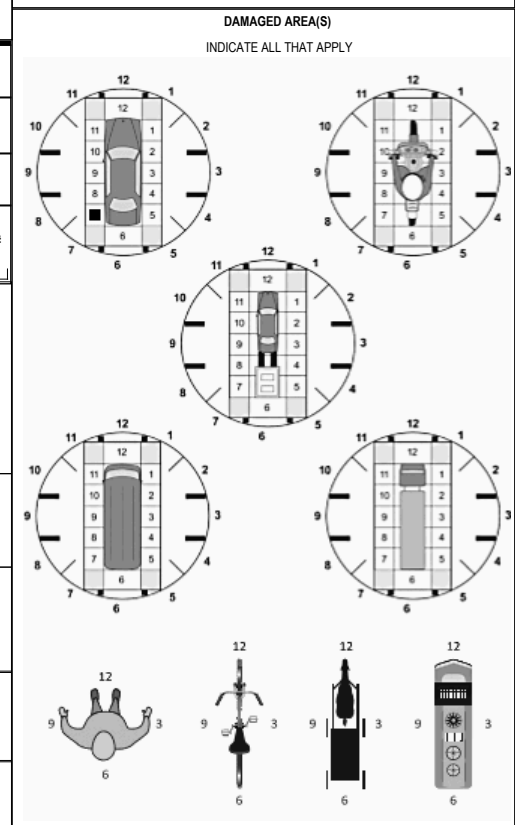
