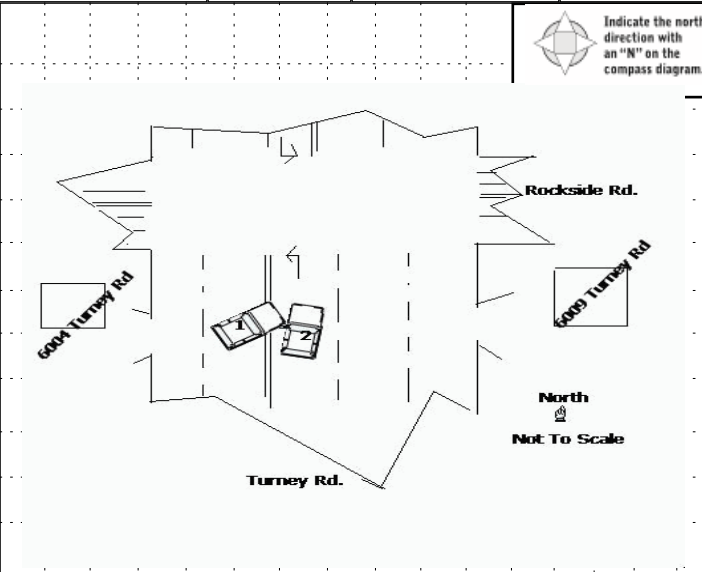

UNIT # 1 WAS TRAVELING EASTBOUND FROM A PRIVATE DRIVEWAY AT 6004 TURNEY RD. APPROXIMATELY 50' SOUTH OF ROCKSIDE RD. INTO THE ROADWAY. UNIT # 2 WAS TRAVELING NORTH ON TURNEY RD. IN THE INSIDE LANE APPROXIMATELY 50' SOUTH OF ROCKSIDE RD. UNIT # 1 FAILED TO YIELD TO THRU TRAFFIC. AS A RESULT, THE RIGHT FRONT OF UNIT # 1 COLLIDED WITH THE LEFT SIDE OF UNIT # 2. BOTH UNITS WERE MOVED FROM FINAL REST AND WERE PARKED AT 6009 TURNEY RD.

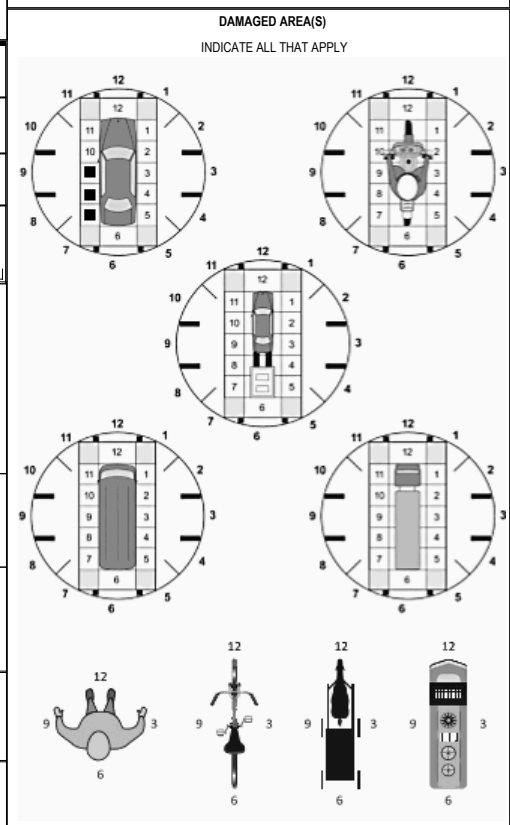
