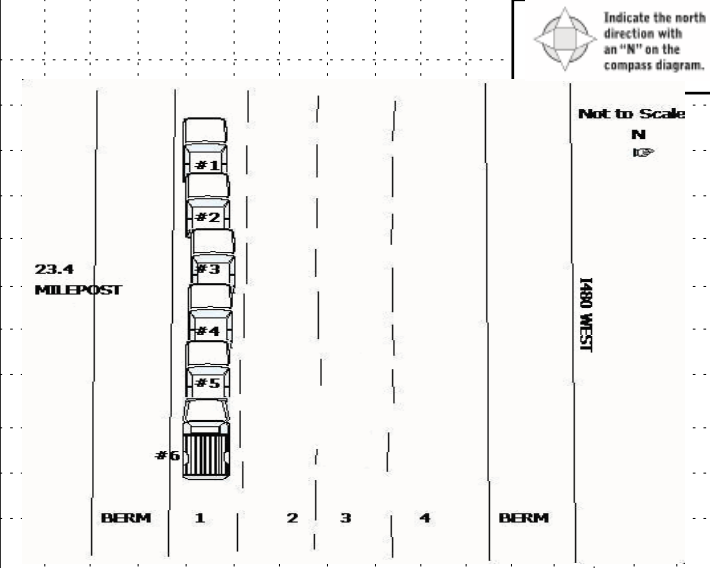

 ALL SIX UNITS WERE TRAVELING WESTBOUND ON I-480 IN THE HIGH SPEED LANE WHEN JUST BEFORE THE VALLEY VIEW BRIDGE TRAFFIC BEGAN TO STOP DUE TO HEAVY TRAFFIC. UNIT #6 WAS THE LAST VEHICLE AND SEEN VEHICLES STOPPING BUT WAS UNABLE TO DO SO (NOTE: BRAKE LINE APPEARED BAD AND WAS LEAKING, DRIVER ALSO STATED PEDAL WAS TO FLOOR) UNIT #6 THEN STRUCK UNIT #5 WHO STRUCK UNIT #4 WHO THEN STRUCK UNIT #3 WHO THEN STRUCK UNIT #2 WHO THEN STRUCK UNIT #1. 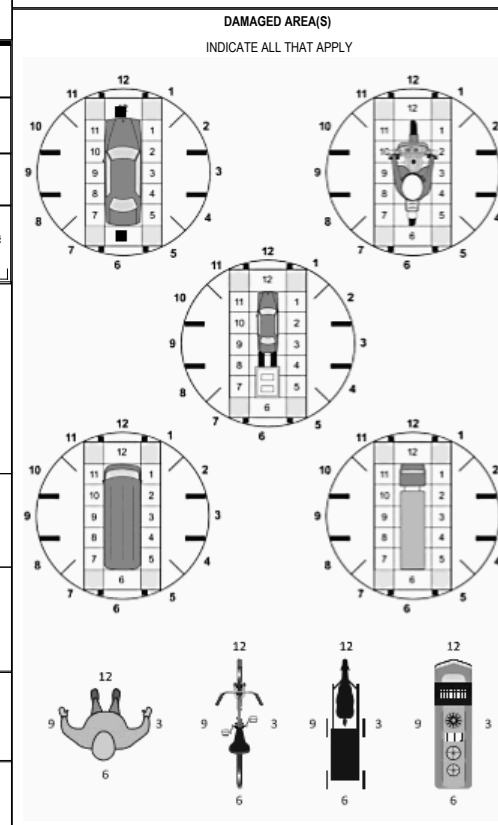

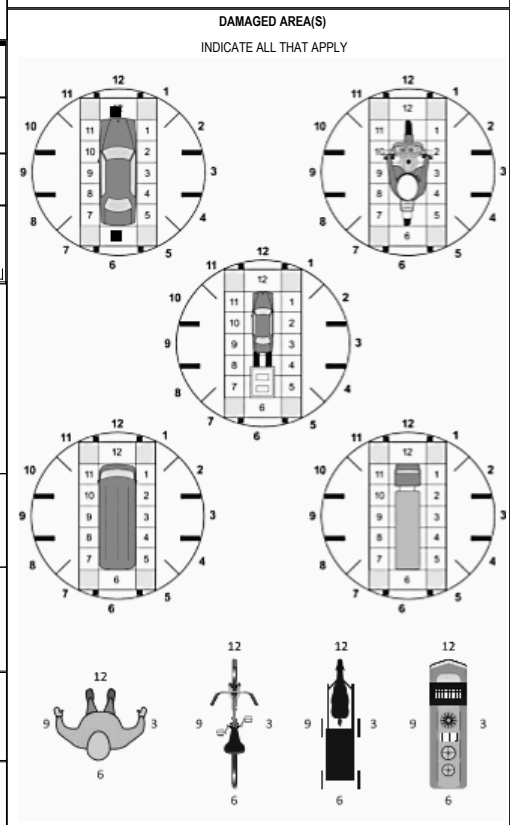

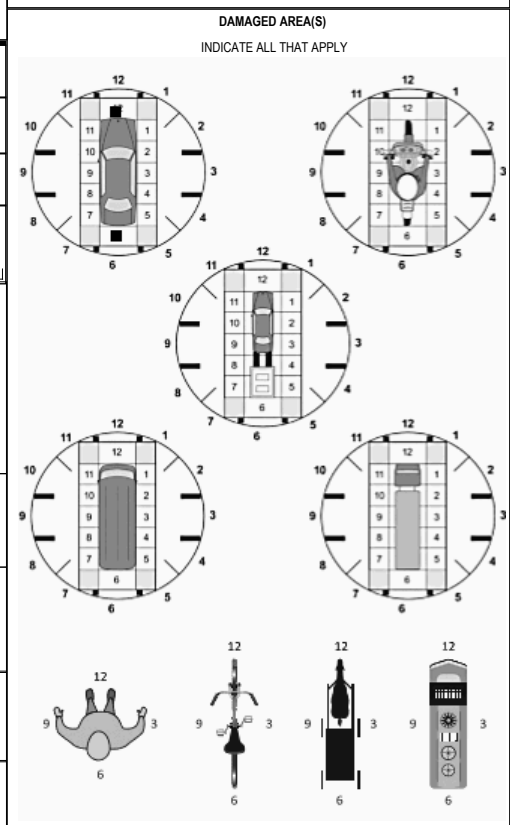
