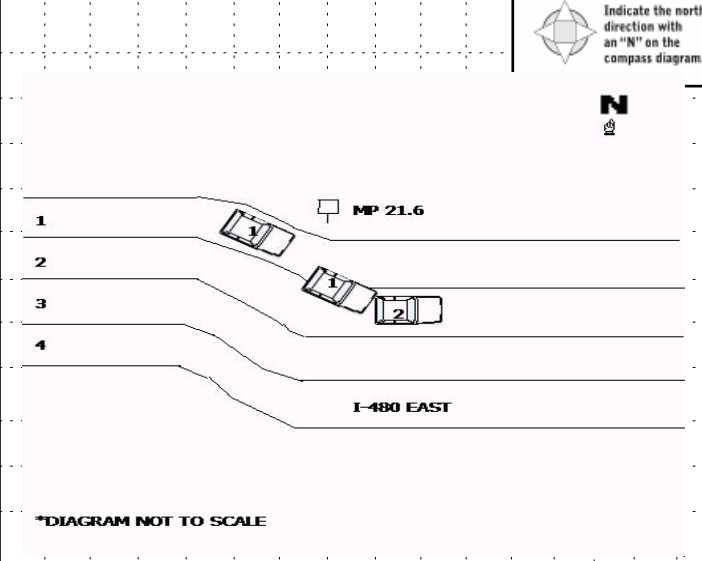

NARRATIVE
 UNIT 2 WAS TRAVELING ON I-480 EAST IN LANE 2.
 UNIT 1 WAS TRAVELING ON I-480 EAST IN LANE 1. AS UNIT 1 APPROACHED MILE POST 21.6, THERE WAS A LANE SHIFT AND HEAVY WATER ON THE ROADWAY. UNIT 1 BEGAN TO HYDROPLANE AND DROVE INTO LANE 2 AND STRUCK THE REAR OF UNIT 2. BOTH VEHICLES PULLED OFF THE ROADWAY ONTO THE LEFT SHOULDER AFTER THE CRASH. DRIVER OF UNIT 1 COMPLAINED OF AN ARM INJURY BUT REFUSED MEDICAL ATTENTION.

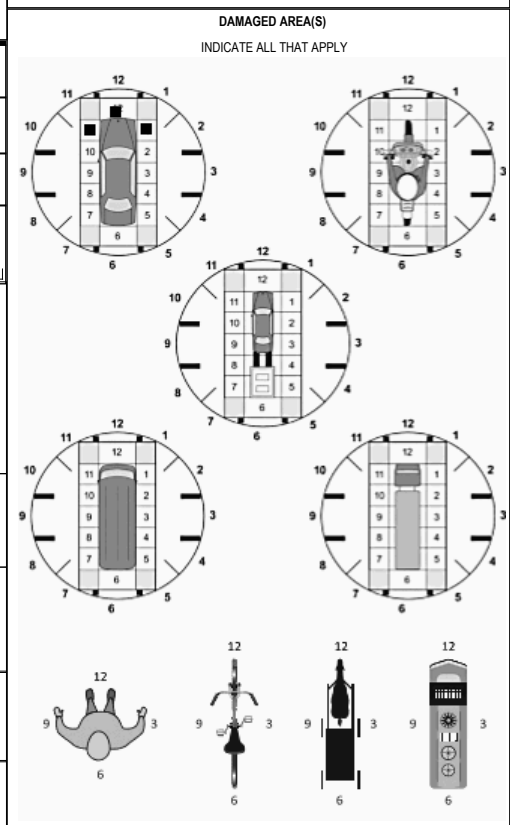

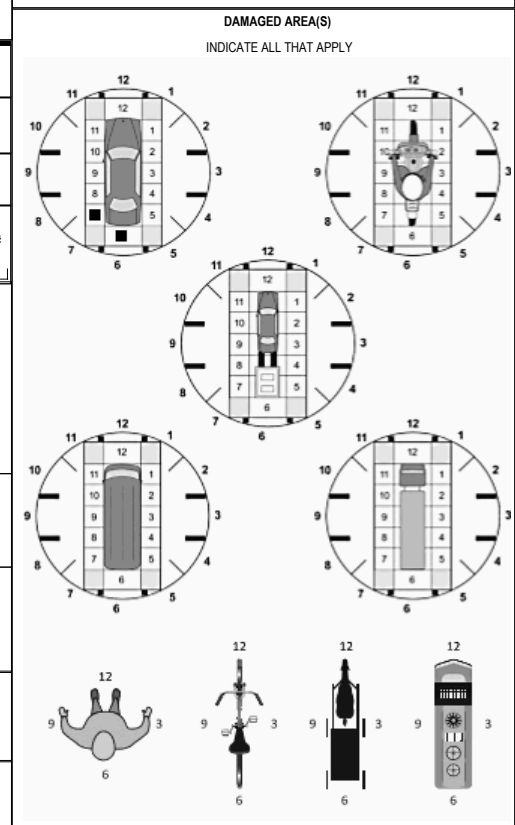
