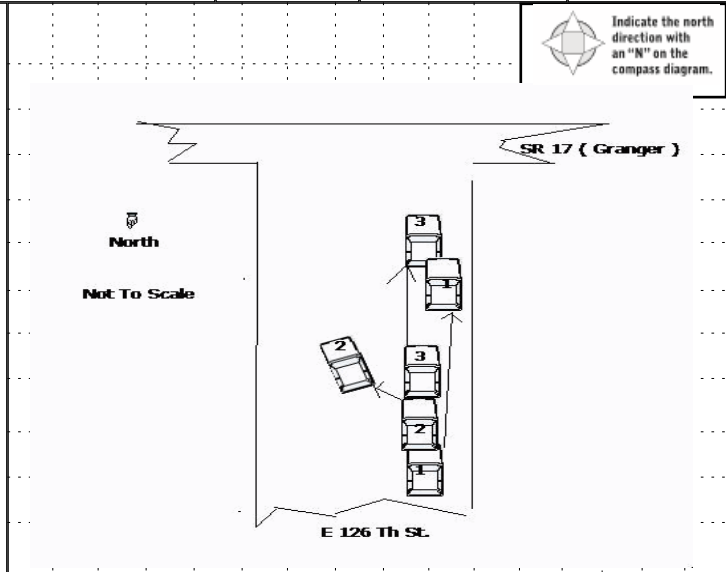

UNIT # 1 WAS TRAVELING SOUTH ON E 126 TH ST. APPROXIMATE 100' NORTH OF SR 17 (GRANGER RD.) DIRECTLY BEHIND UNIT # 2. UNIT # 2 WAS DIRECTLY BEHIND UNIT # 3. UNIT # 2 AND UNIT # 3 WERE STOPPED FOR TRAFFIC. AS A RESULT, THE FRONT OF UNIT # 1 COLLIDED WITH THE REAR OF UNIT # 2. THE RIGHT FRONT OF UNIT # 2 COLLIDED WITH THE LEFT REAR OF UNIT # 3 AND CONTINUED TO TRAVEL IN A SOUTHEASTERN DIRECTION AFTER BEING STRUCK. UNIT # 1 CONTINUED IN A SOUTHERN DIRECTION AND THE FRONT COLLIDED WITH THE REAR OF UNIT # 3. UNITS WERE AT FINAL REST.

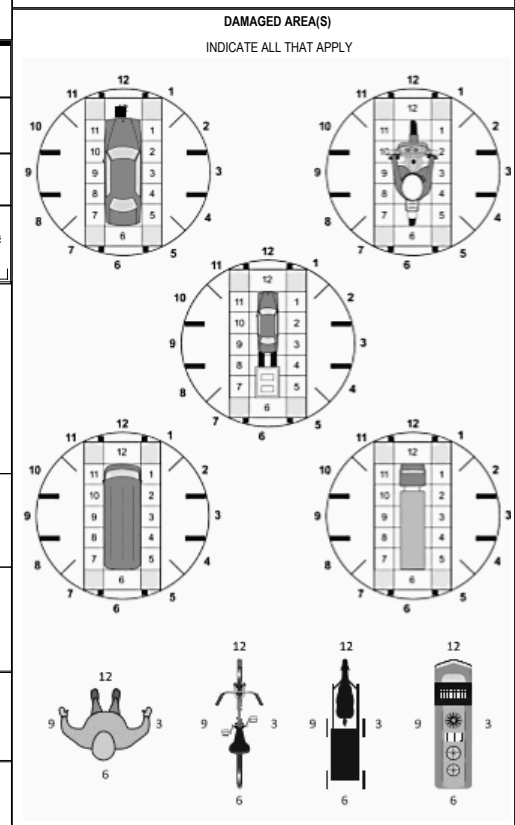

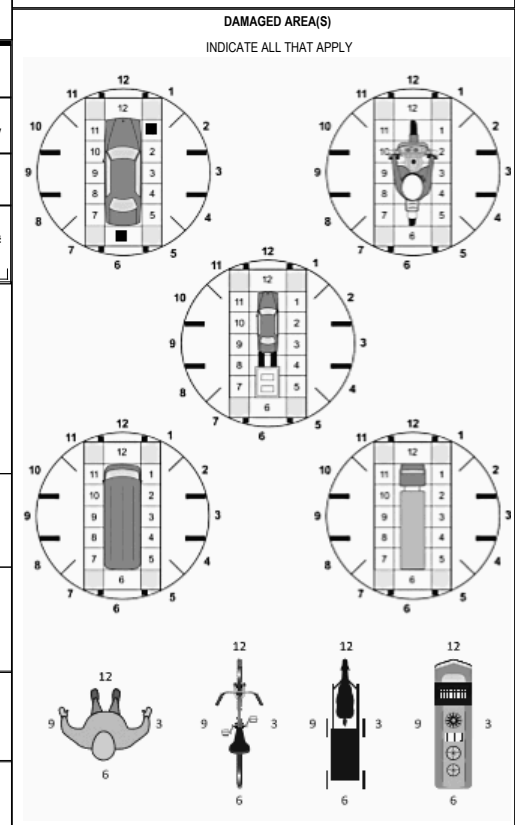
