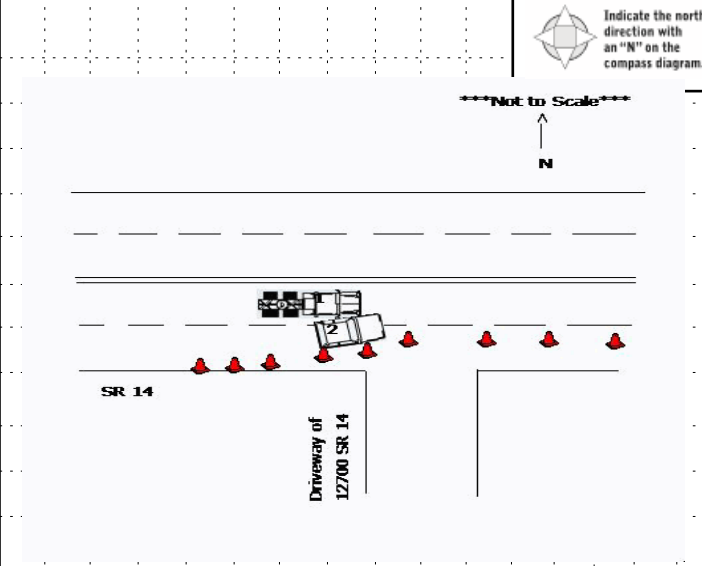

NARRATIVE
 UNIT #1 WAS STOPPED IN HEAVY TRAFFIC IN THE CENTER LANE IN FRONT OF 12700 SR 14 E/B. UNIT #2 WAS TRAVELLING IN THE CURB LANE NEXT TO UNIT #1 AND APPROACHED CONSTRUCTION BARRELS CLOSING HER LANE. AS SHE LOST HER LANE OF TRAVEL, SHE ATTEMPTED TO MOVE TO THE LEFT AND ENTERED THE LANE OF TRAVEL OF UNIT #1. WHEN SHE DID THIS, HER VEHICLE STRUCK THE RIGHT FRONT TIRE LUGS OF UNIT #1. THERE WAS NO DAMAGE TO UNIT #1. BOTH VEHICLES WERE ABLE TO BE DRIVEN AWAY AFTER THE CRASH.

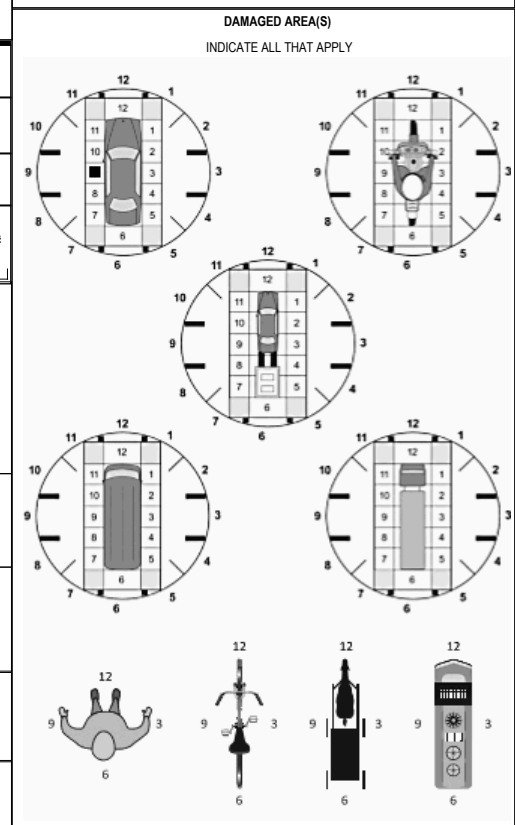
