UNIT #1 WAS TRAVELING EAST ON IR 480 IN THE MIDDLE OUTSIDE LANE APPROXIMATELY 100' WEST OF MILE POST 24.2. UNIT #2 AND UNIT #3 (NON CONTACT UNITS) WERE TRAVELING EAST IN UNKNOWN LANES (UNDEFINED) RACING. UNIT #1 TOOK EVASIVE ACTION TO THE RIGHT ONTO THE OFF RAMP TO AVOID A COLLISION. AS A RESULT, UNIT #1 TRAVELED OFF THE ROADWAY TO THE LEFT AND COLLIDED WITH A SIGN AND CONTINUED IN A EASTERN DIRECTION. THE LEFT FRONT COLLIDED WITH A TREE.
