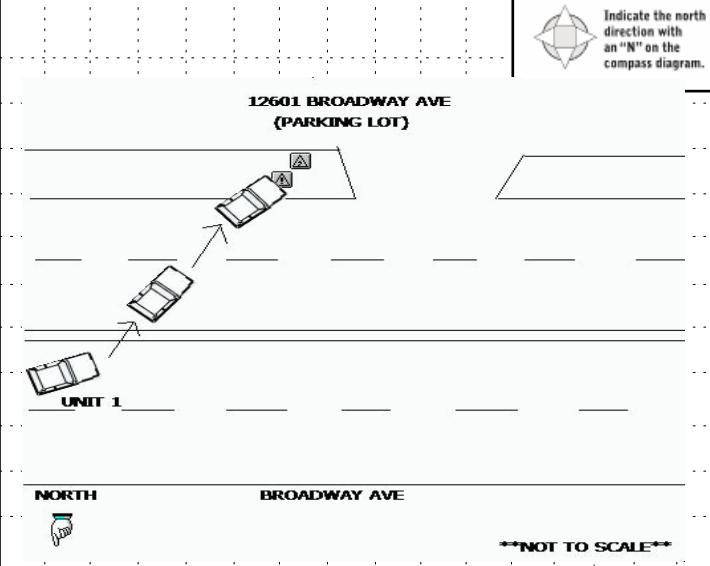

 UNIT ONE WAS TRAVELING W/B ON SR 14 (BROADWAY AVENUE), IN THE CENTER LANE. AS UNIT ONE WAS TRAVELING W/B ON BROADWAY, THE DRIVER FELT A VIOLENT JERK OR POP IN THE AREA OF THE FRONT LEFT TIRE. THE DRIVER THEN LOST CONTROL OF UNIT ONE, TRAVELED LEFT OF CENTER AND JUMPED OVER THE CURB ON THE SOUTH SIDE OF SR 14. IT WAS AT THAT POINT UNIT ONE STRUCK A CEMENT POST AND A CITY FIRE HYDRANT.

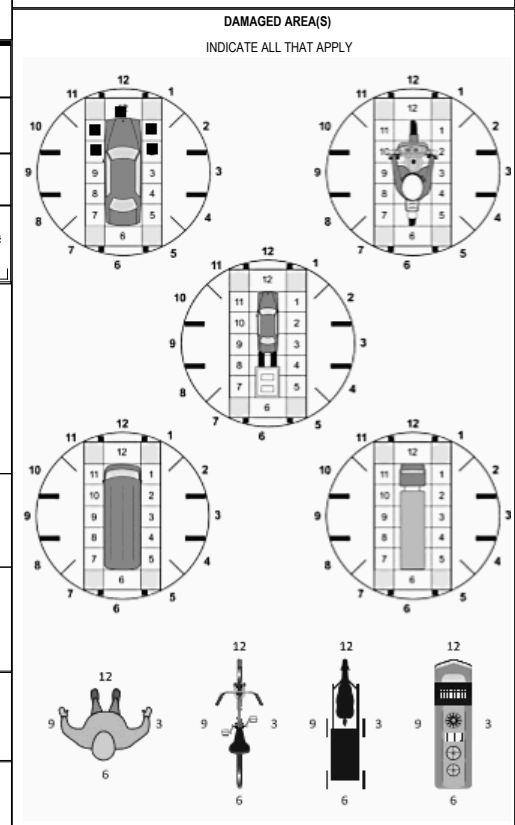
