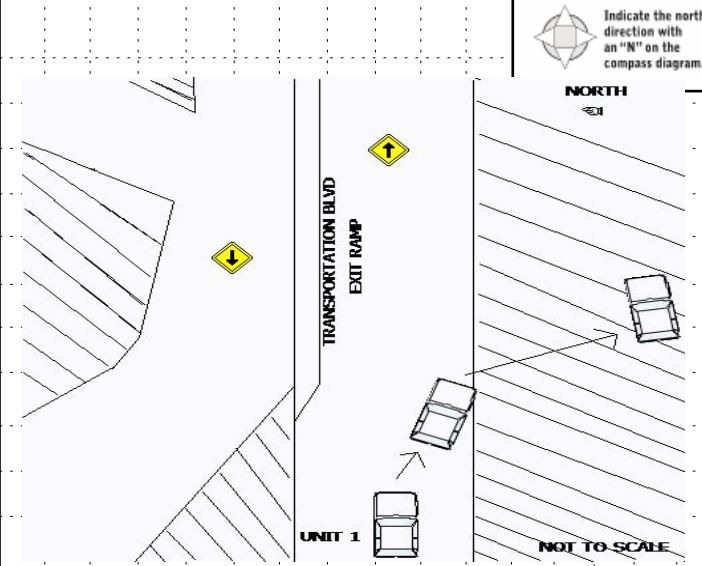

UNIT ONE WAS TRAVELING E/B ON IR 480 EAST, APPROACHING THE TRANSPORTATION BOULEVARD EXIT RAMP. DRIVER OF UNIT ONE STATED, AS SHE WAS ENTERING THE EXIT RAMP, SHE STRUCK LARGE PUDDLE OF WATER, CAUSING HER TO HYDROPLANE. UNIT ONE LOST CONTROL, RAN OFF OF THE RIGHT SIDE OF THE EXIT RAMP AND DOWN A DEEP EMBANKMENT.
