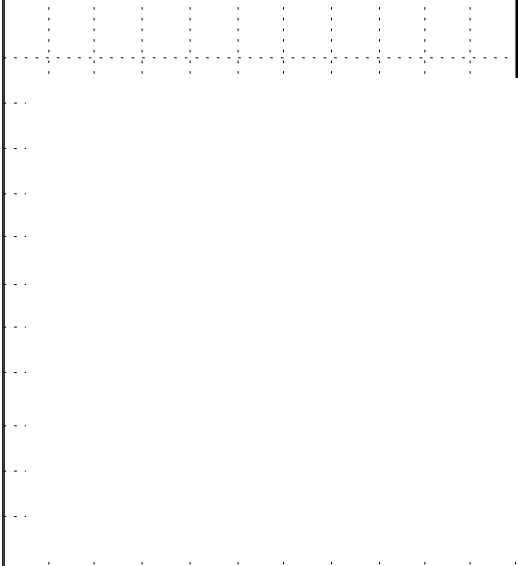

NARRATIVE
 UNIT ONE WAS TRAVELING SOUTHBOUND ALONG THE DRIVEWAY OF 15166 NEO PARKWAY. AS THE DRIVER OF UNIT ONE WAS EXECUTING A LEFT HAND TURN, HE BEGAN TO PUSH ON THE ACCELERATOR TO SPEED UP; CAUSING HIM TO LOSE CONTROL OF UNIT ONE AND STRIKE A TREE ON THE NORTH SIDE OF THE DRIVEWAY.

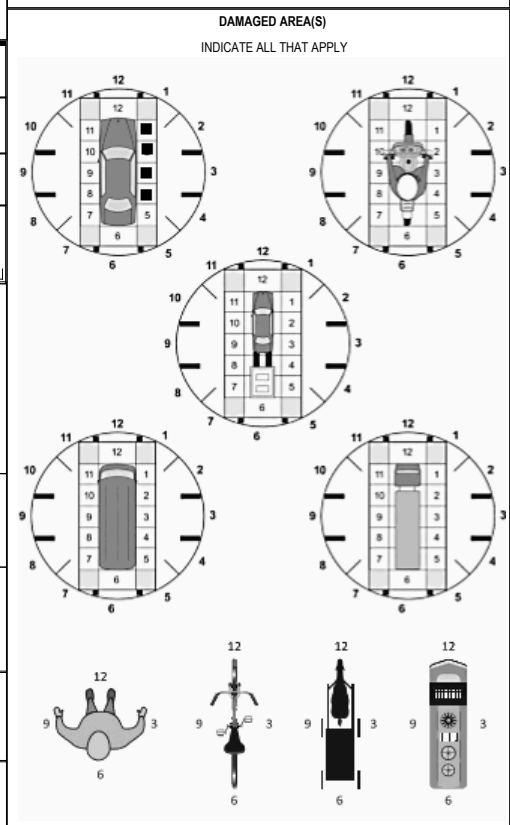
