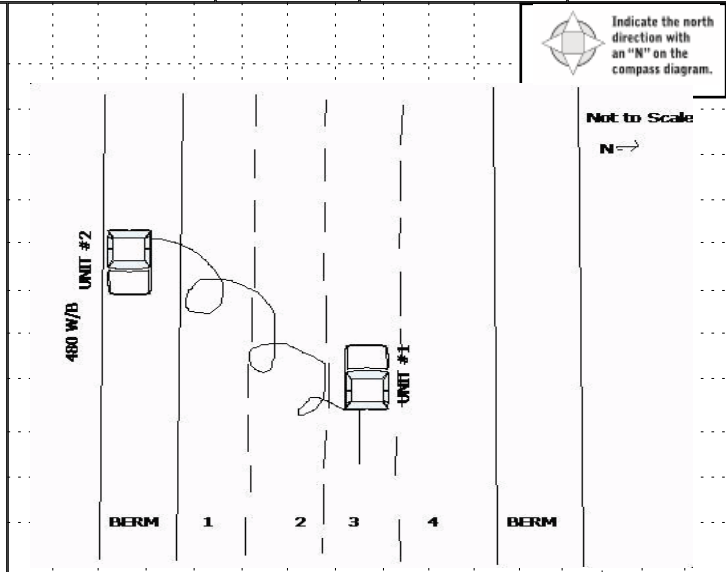

ON SEPTEMBER 28, 2021 AT ABOUT 1844 HOURS

UNIT #1 WAS TRAVELING WEST ON I 480 IN LANE EITHER LANE 2 OR 3 NEAR THE VALLEY VIEW BRIDGE ALONG WITH UNIT #2 IN THE SAME DIRECTION AND AREA. UNIT #2 REAR ENDED UNIT #1, THEN BEGAN TO SPIN UNTIL IT COLLIDED WITH THE LEFT SIDE WALL. NEITHER DRIVER ON SCENE COULD RECALL THE EXACT EVENTS OF THE ACCIDENT, THE INFORMATION DOCUMENTED WAS OBTAINED FROM VIDEO OF THE ACCIDENT TAKEN BY ODOT TRAFFIC CAMERA FOOTAGE.

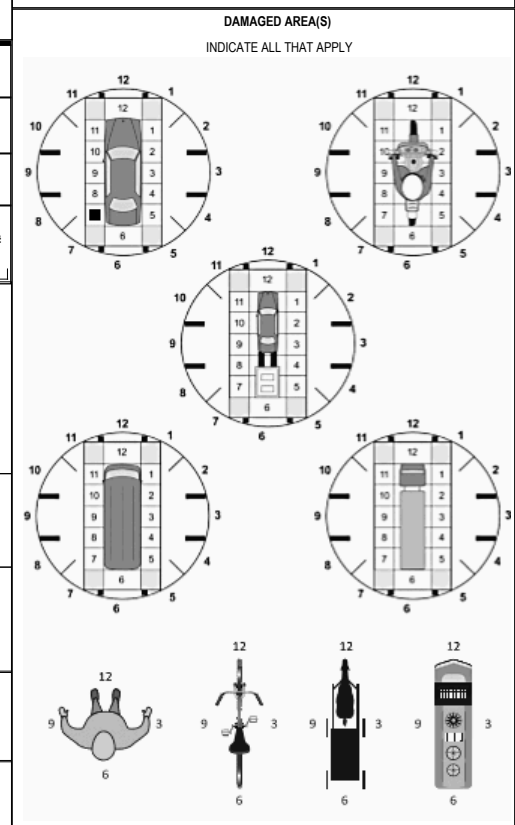

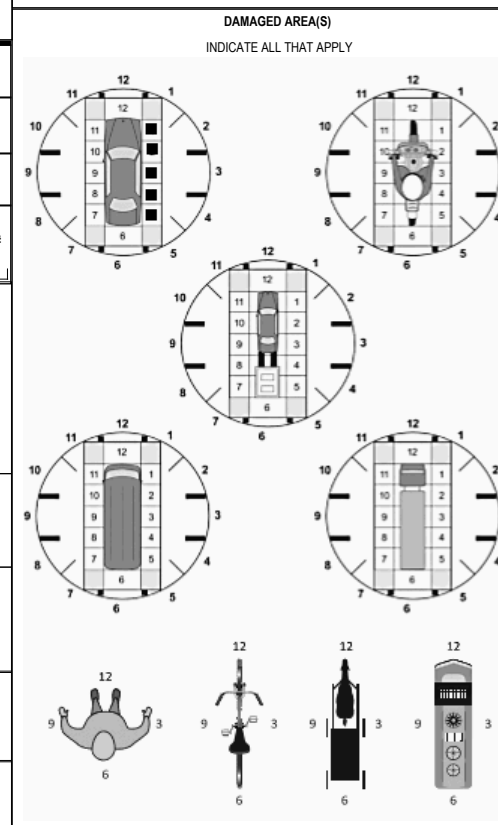
