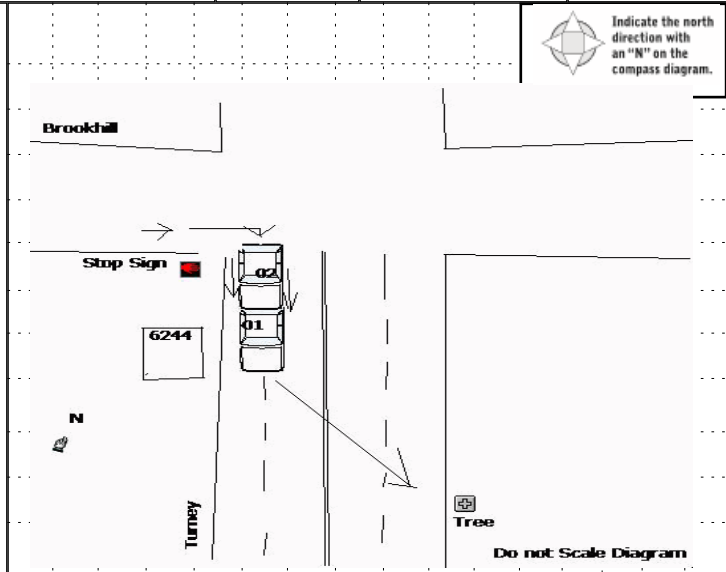

UNIT 01 STATED WHEN HE MADE A RIGHT TURN ONTO TURNEY FROM BROOKHILL HE WAS STRUCK IN THE REAR BY UNIT 02 CAUSING HIM TO LOSE CONTROL OF HIS VEHICLE AND STRIKE A TREE. UNIT 02 STATED WHILE TRAVELING SOUTH ON TURNEY UNIT 01 SUDDENLY OPERATED ONTO TURNEY FROM A STOP SIGN ON BROOKHILL. UNIT 02 STATED HE DID NOT HAVE ENOUGH TIME AND DISTANCE TO STOP HIS VEHICLE CAUSING HIM TO STRIKE UNIT 01 IN THE REAR.

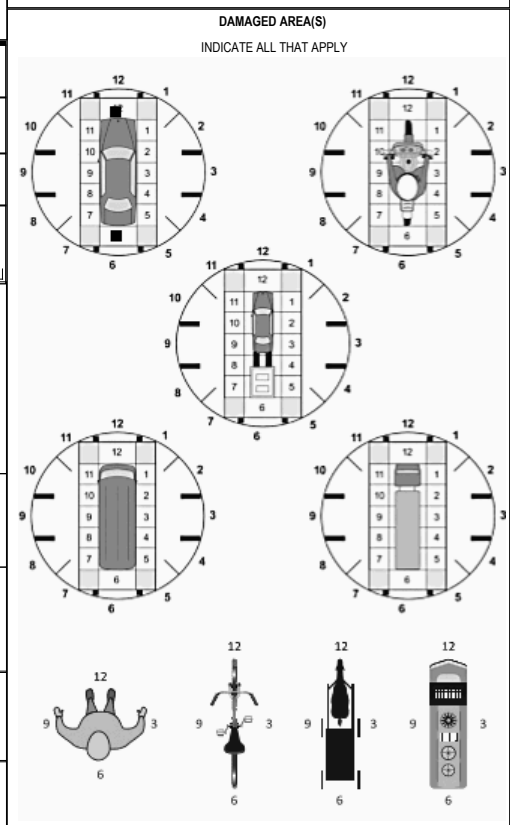
