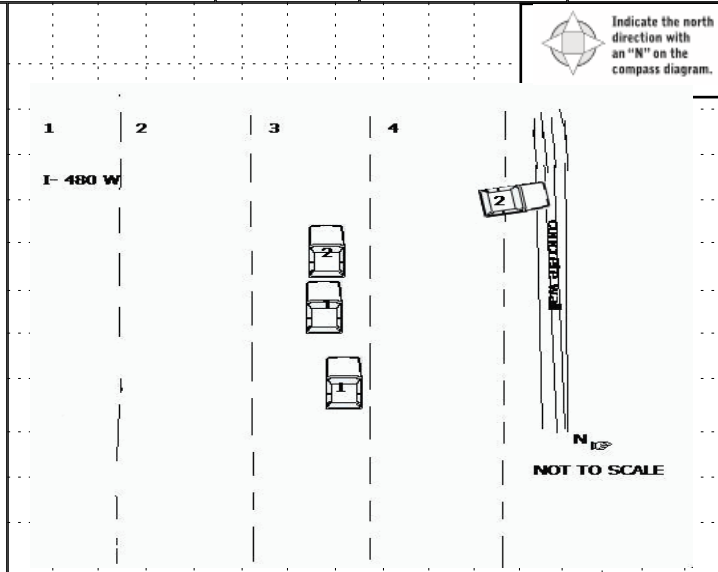

UNIT 2 SPUN OUT AND STRUCK A CONCRETE MEDIAN WITH FRONT BUMPER. UNIT 1 STATED SHE WAS TRAVELING WESTBOUND ON IR 480 IN LANE 3 DIRECTLY BEHIND UNIT 2. UNIT 1 STATED SHE THEN STRUCK UNIT 2 IN REAR BUMPER WHILE IT WAS SWERVING.

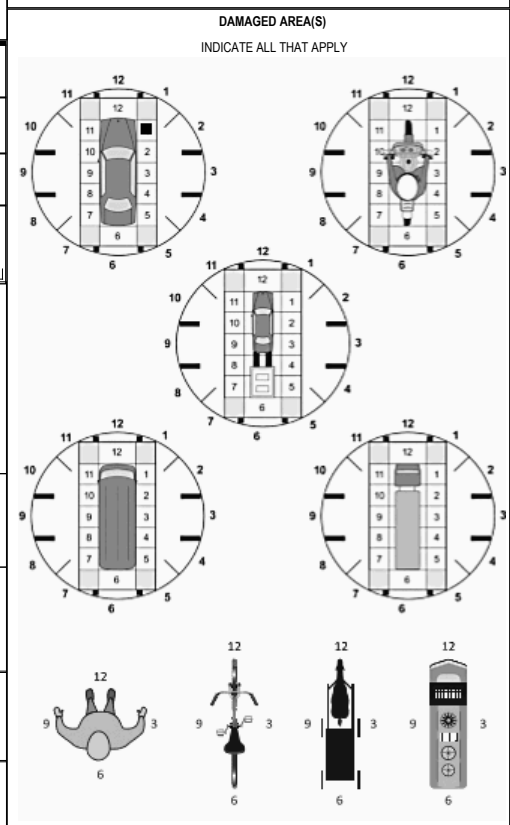
