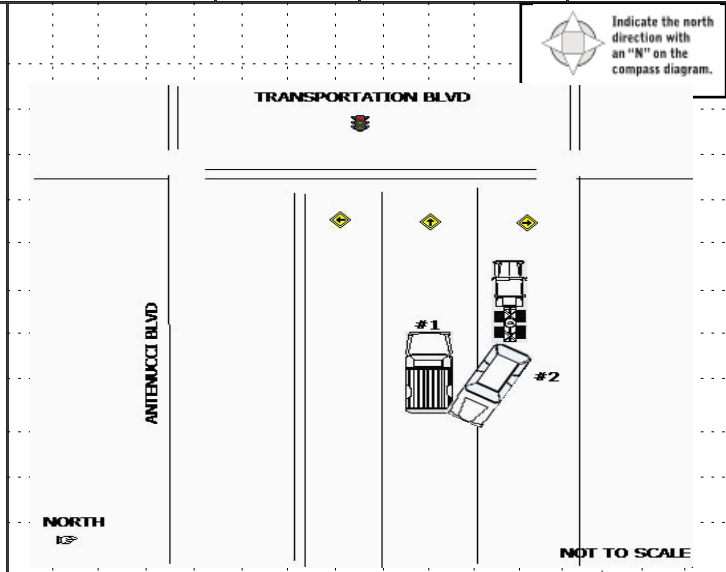

NARRATIVE

UNIT ONE WAS STOPPED FOR A RED TRAFFIC SIGNAL AT THE INTERSECTION OF ANTENUCCI AND TRANSPORTATION BOULEVARD, IN THE CENTER LANE, FACING WESTBOUND. UNIT TWO WAS TRAVELING BEHIND UNIT ONE, MERGING INTO THE CURB LANE. UNIT TWO WAS BEING TOWED BY AN ICON TOWING TOW TRUCK. AS UNIT TWO WAS PASSING UNIT ONE, IT BECAME PARTIALLY UNSECURE FROM THE TOW TRUCK AND STRUCK UNIT ONE IN THE RIGHT, REAR QUARTER PANEL.
