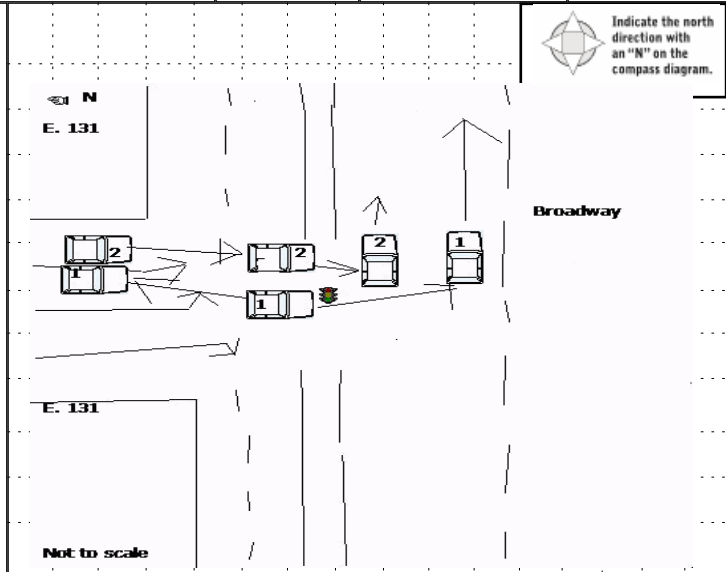

UNIT 2 WAS MAKING LEFT TURN FROM NORTHBOUND ON E. 131 STREET TO EASTBOUND ONTO BROADWAY. UNIT 1 THEN WAS MAKING LEFT FROM E. 131 STREET ONTO BROADWAY AND MADE IMPROPER PASSING AND STRUCK UNIT 2'S LEFT SIDE AUTO WITH UNIT 1'S DRIVER SIDE AUTO. UNIT 1 LEFT THE SCENE AND CONTINUING ON EASTBOUND ON BROADWAY WITHOUT STOPPING. UNIT 1 IS MARKED HIT SKIP AND IS AT FAULT. THE VEHICLE IS LATER DISCOVERED AND WAS PARKED AT THE E. 141 APARTMENTS.

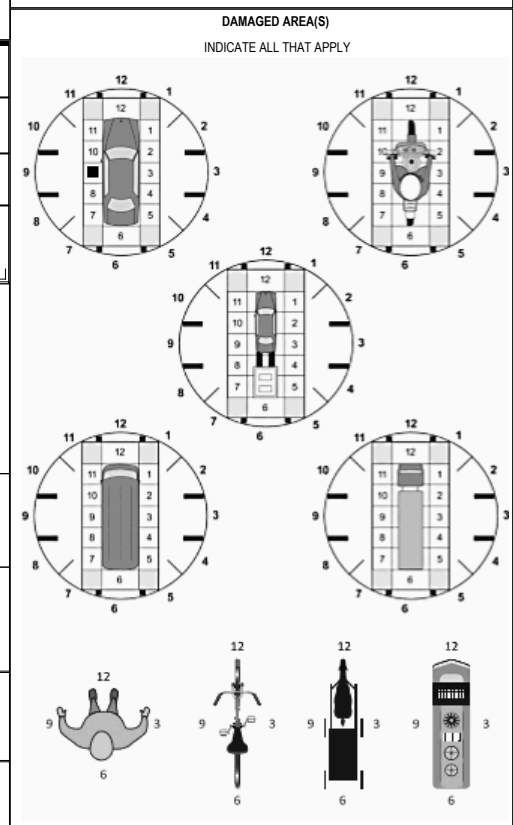

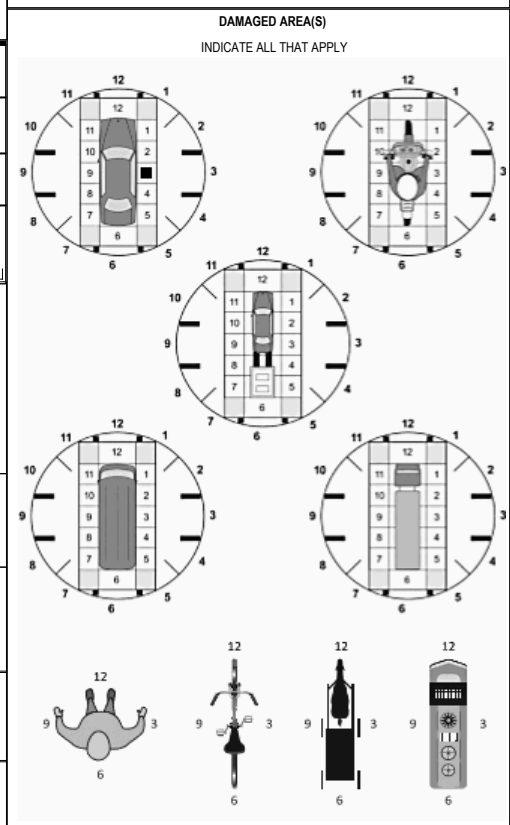
