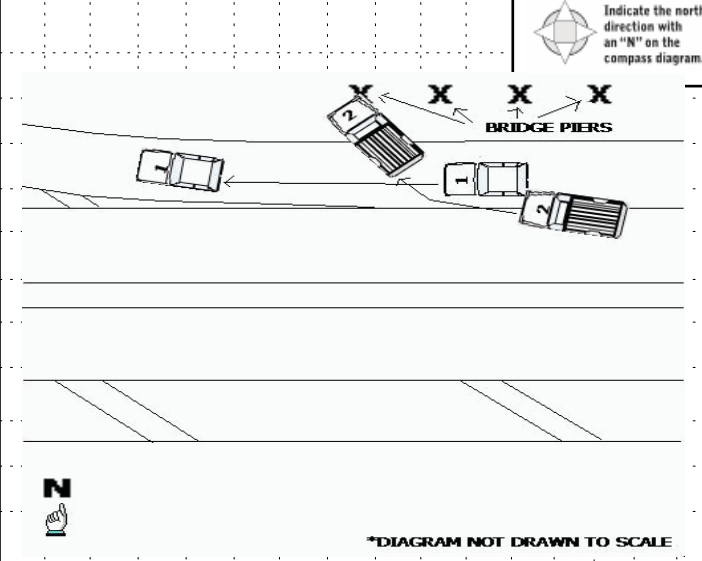

 UNIT 1 WAS TRAVELING IN THE RIGHT LANE OF W/B S.R. 17 APPROACHING THE I.R. 480 W/B ENTRANCE. UNIT 2 WAS TRAVELING IN THE LEFT LANE OF S.R. 17 APPROACHING UNIT 1. UNIT 2 LOST CONTROL AND VEERED INTO THE RIGHT LANE CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE LEFT REAR. THE IMPACT FROM UNIT 2 CAUSED UNIT 1 TO TRAVEL APPROXIMATELY 50 FEET FORWARD WHILE UNIT 2 TRAVELED OFF OF THE ROADWAY TO THE RIGHT ONTO THE SIDEWALK. UNIT 2 THEN STRUCK THE I.R. 480 W/B OVERPASS BRIDGE PIER WHERE IT CAME TO FINAL REST.

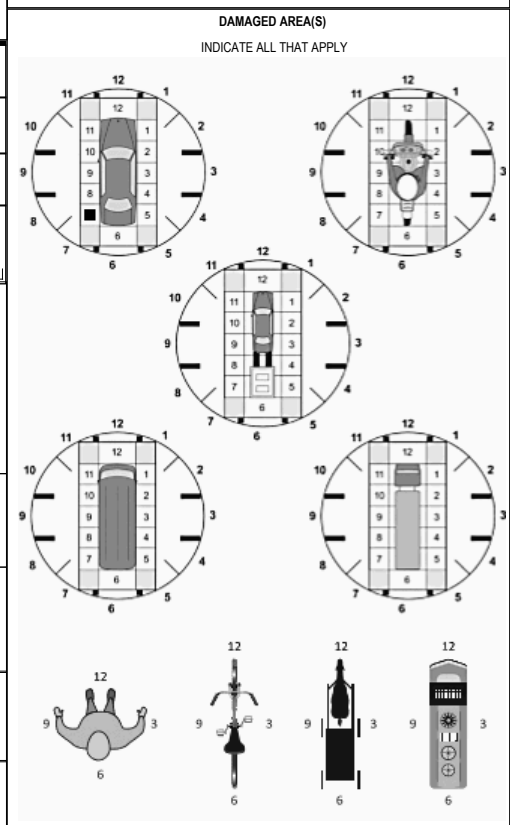

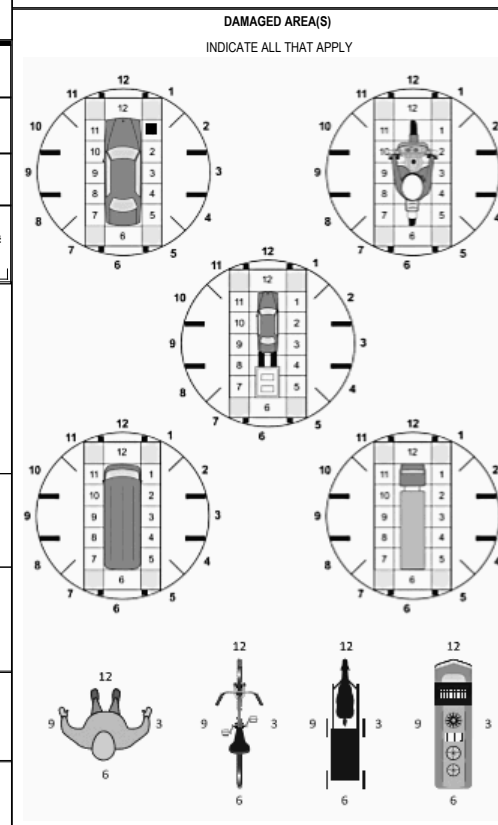
