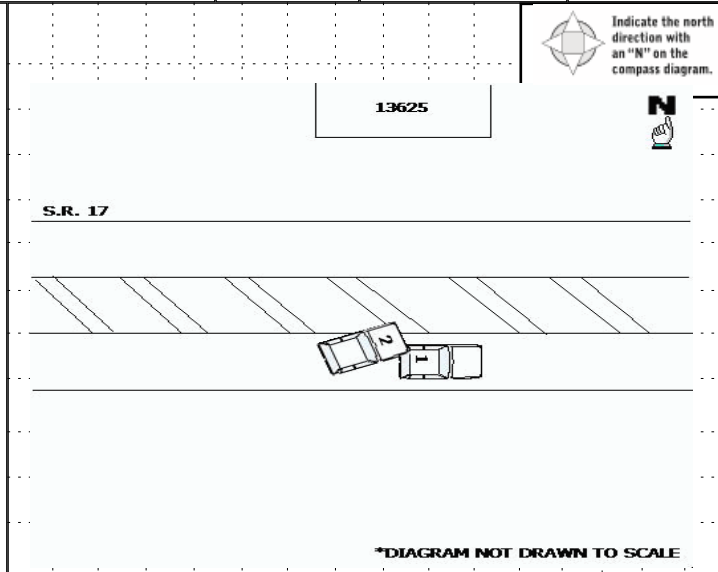

UNIT 2 FAILED TO STOPPED IN TIME FOR UNIT 1 CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE LEFT REAR. THE OPERATOR OF UNIT 2 THEN LEFT THE SCENE OF THE CRASH ON FOOT WITHOUT OBTAINING OR PROVIDING REQUIRED CRASH INFORMATION.

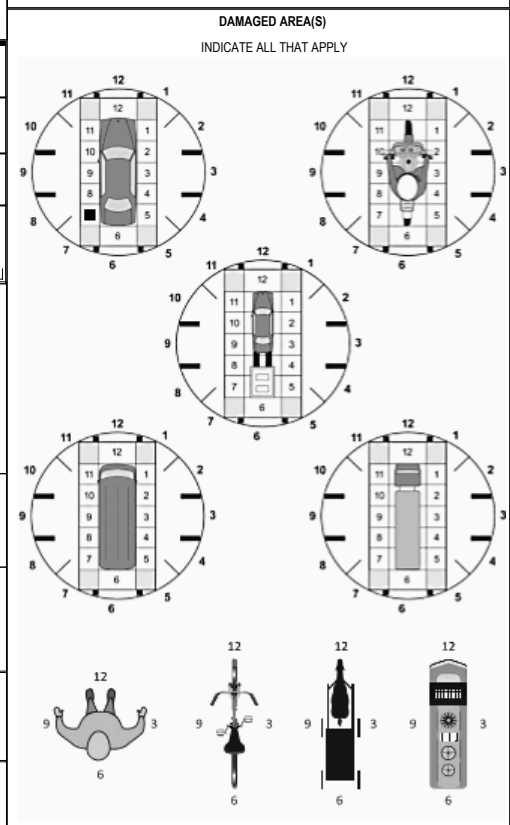

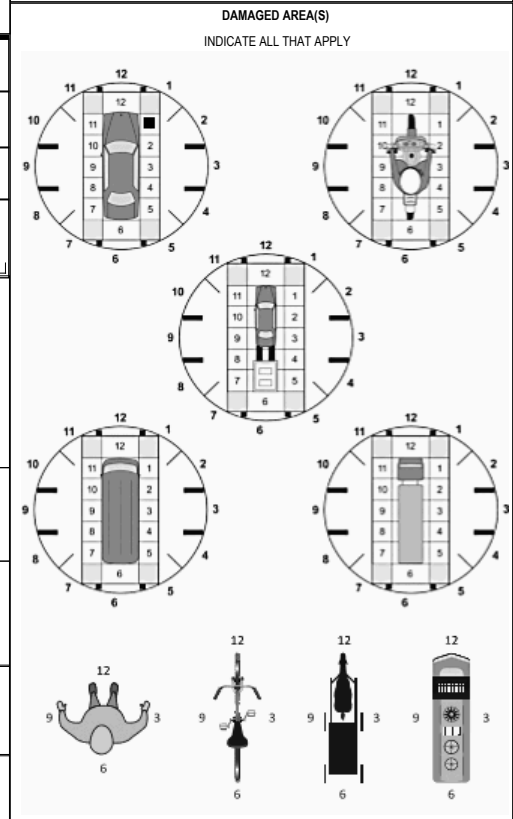
