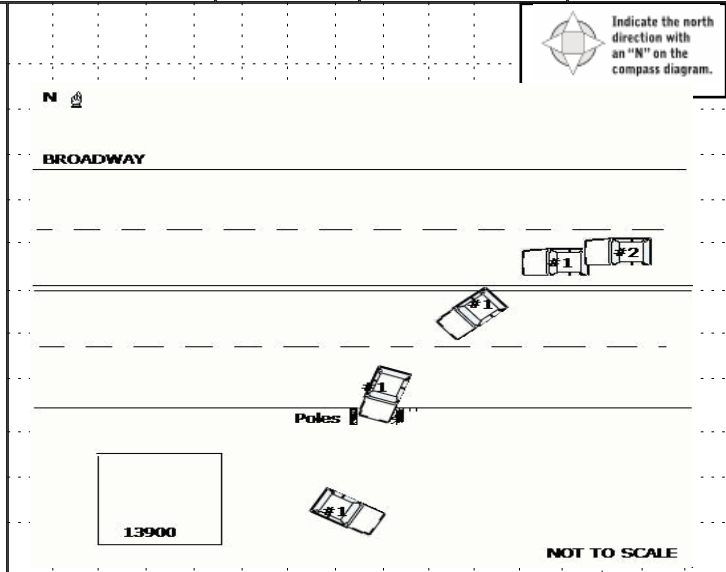

NARRATIVE

UNIT #1 WAS TRAVELING WEST ON BROADWAY WHEN A SMALL SILVER VEHICLE UNIT #2 WAS APPROACHING FROM BEHIND HER IN THE SAME DIRECTION AT A HIGH RATE OF SPEED. UNIT #2 THEN WENT TO PASS UNIT #1 AND STRUCK IT IN THE RIGHT REAR FENDER AREA. THIS CAUSED UNIT #1 TO LOSE CONTROL AND CROSS OVER INTO THE OPPOSITE LANES OF TRAFFIC THEN OFF THE ROADWAY STRIKING TWO CONCRETE POLES AND COMING TO REST IN THE PARKING LOT OF 13900 BROADWAY. UNIT #2 DID NOT STOP AND CONTINUED WEST ON BROADWAY

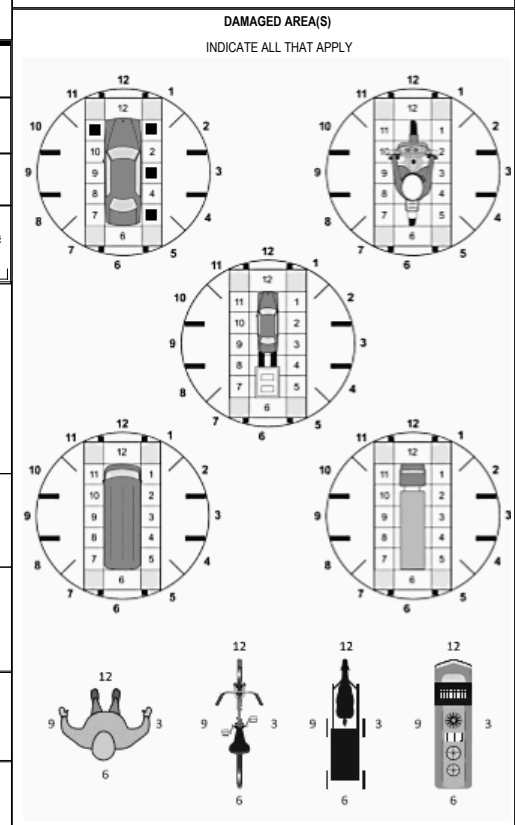
