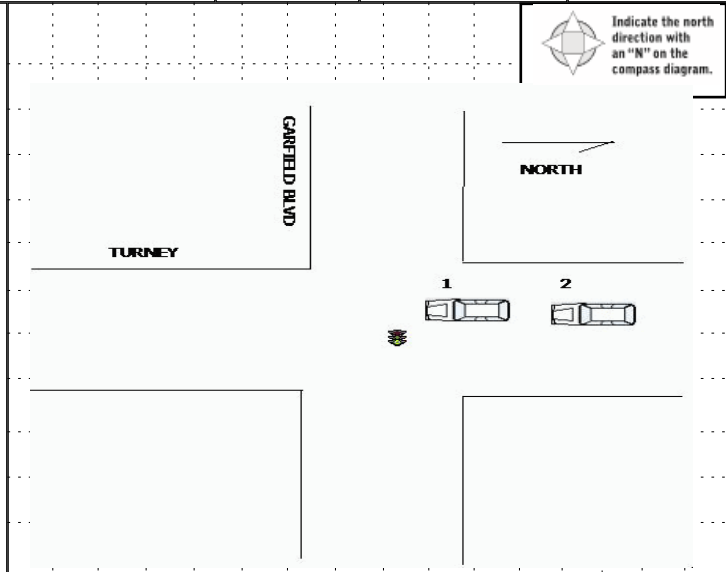

UNIT 2 WAS TRAVELING DIRECTLY BEHIND UNIT 1 IN THE SAME DIRECTION, UNIT 2 STOPPED THEN UNIT 1 BACKED INTO UNIT 2. BOTH PULLED OVER AND UNIT 1 DROVE OFF. UNIT 2 STATES UNIT 1 WAS A PONTIAC TAN IN COLOR. THE DRIVER OF UNIT 1 WAS A BLACK MALE IN HIS TWENTIES. NO OTHER INFO ON UNIT 1.
