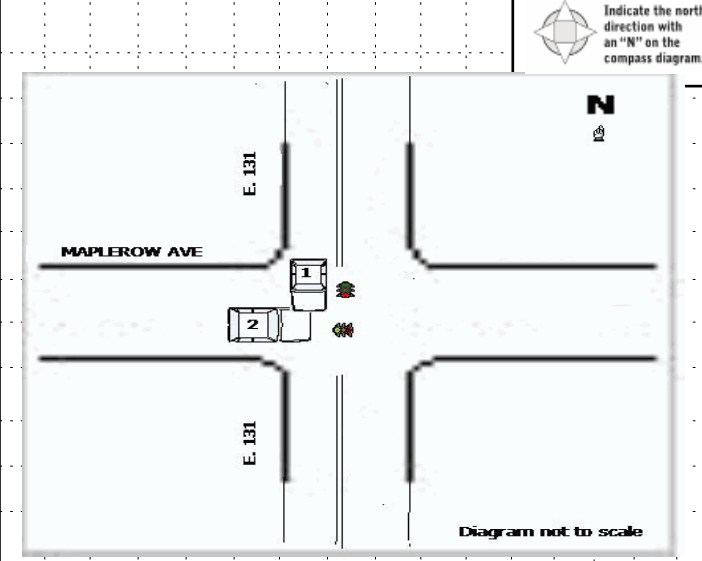

NARRATIVE
 DRIVER OF UNIT 2 STATED THAT UNIT 2 STOPPED AT THE RED LIGHT ON MAPLEROW AVE E/B AT EAST 131 ST. THE LIGHT TURNED GREEN AND UNIT 2 BEGAN TO DRIVE STRAIGHT INTO THE INTERSECTION, WHEN IT WAS STRUCK ON THE LEFT FRONT BY UNIT 1, WHICH WAS TRAVELING S/B ON EAST 131 ST. THE DRIVER OF UNIT 1 STATED THAT HE TRIED TO STOP AT THE RED LIGHT BUT UNIT 1 SLID ON A PATCH OF ICE AND TRAVELED INTO THE INTERSECTION AND STRUCK UNIT 2.

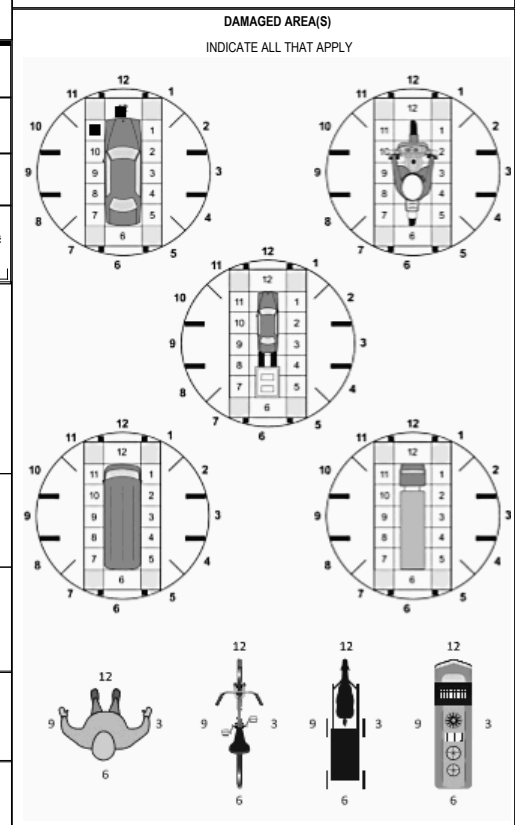
