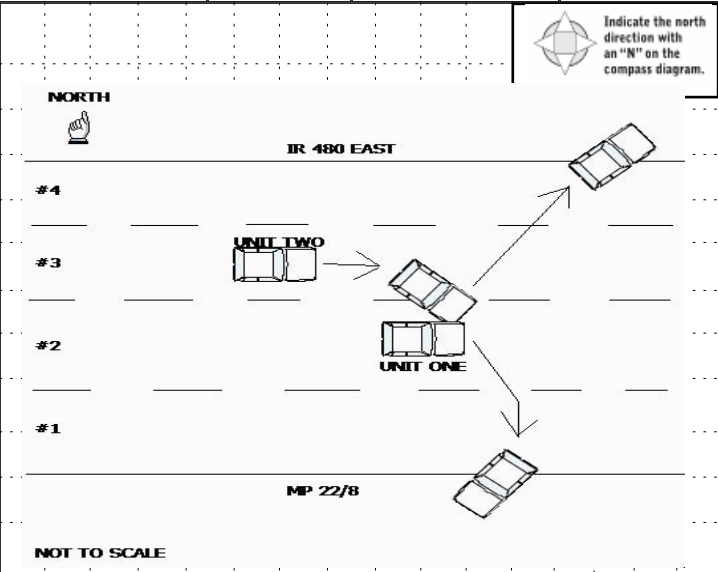

NARRATIVE

UNIT ONE WAS TRAVELING EASTBOUND ON IR480 EAST, IN THE NUMBER THREE LANE. UNIT TWO WAS ALSO TRAVELING EASTBOUND ON IR480 EAST, BUT WAS USING THE NUMBER TWO LANE. AS UNIT ONE APPROACHED MILE POST 22/8, THE OPERATOR FAILED TO MAINTAIN CONTROL OF THE VEHICLE, SWERVING BACK AND FORTH ACROSS ALL LANES UNTIL IT SPUN OUT OF CONTROL AND STRUCK UNIT ONE IN THE FRONT LEFT QUARTER PANEL.
