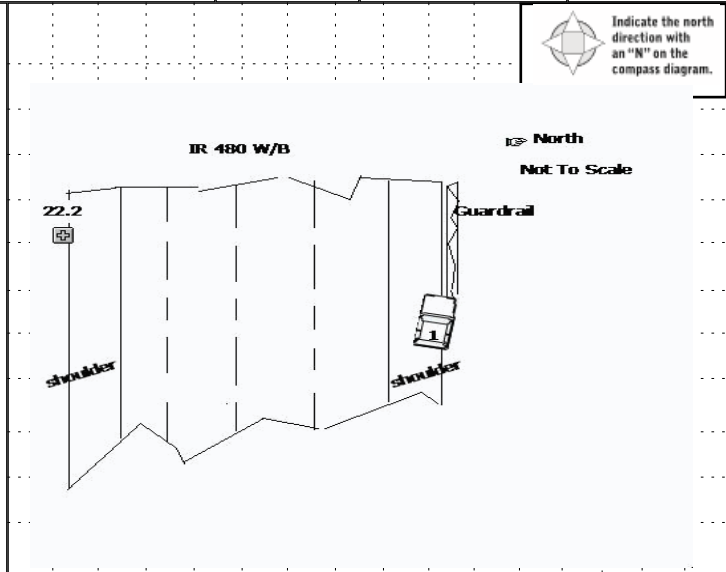

NARRATIVE

UNIT # 1 WAS TRAVELING WEST ON IR 480 WESTBOUND IN THE OUTSIDE LANE. UNIT # 1 FAILED TO MAINTAIN CONTROL. AS A RESULT, UNIT # 1 TRAVELED THROUGH THE NORTH SHOULDER AND OFF THE RIGHT SIDE OF ROADWAY. THE FRONT OF UNIT # 1 COLLIDE WITH THE CRASH CUSHION OF THE GUARD RAIL. UNIT # 1 ROTATED COUNTER CLOCK WISE AND WAS AT FINAL REST IN THE OUTSIDE LANE FACING SOUTHWEST.

NOTE: DRIVER OF UNIT # 1 WAS RELOCATED TO A SAFER AREA AND STATED, SHE HIT ICE.
