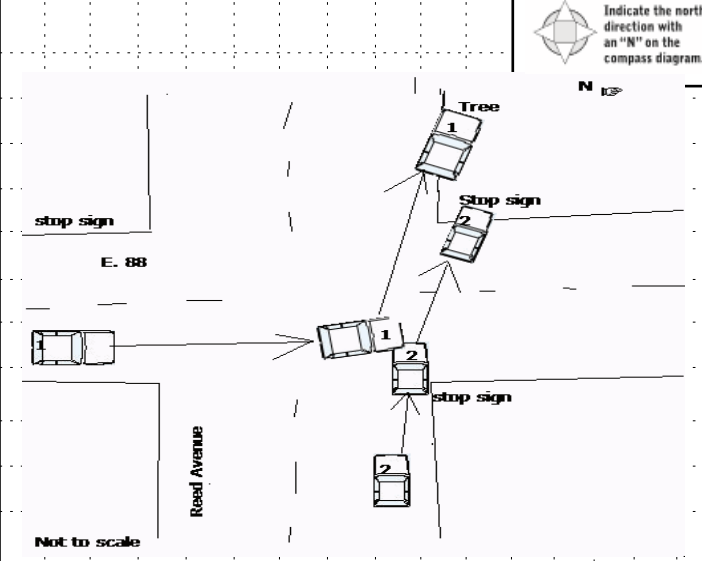

UNIT 1 STATED HE WAS TRAVELING NORTHBOUND ON E. 88 STREET APPROACHING A STOP SIGN INTERSECTION BETWEEN REED AVENUE AND E. 88 STREET. UNIT 1 STATED HE ATTEMPTED TO APPLY THE BREAKS TO STOP AT THE STOP SIGN BUT DID NOT WORK DUE TO THE SNOW ON THE GROUND. AS A RESULT, HE STRUCK UNIT 2 IN THE FRONT LEFT OF UNIT 1'S FRONT RIGHT. UNIT 1 STATED HE SPAN OUT OF THE ROAD WAY AND STRUCK A TREE HEAD ON IN THE BACKYARD OF 4878 E. 88 STREET FOR FINAL REST.

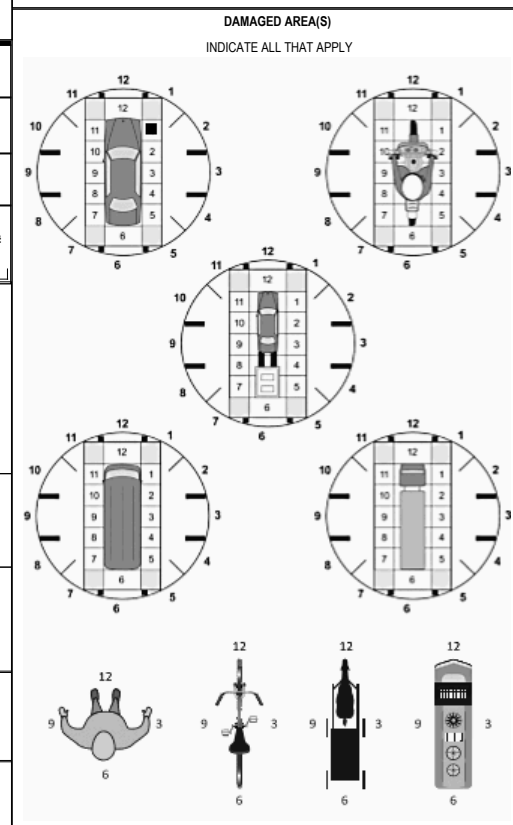

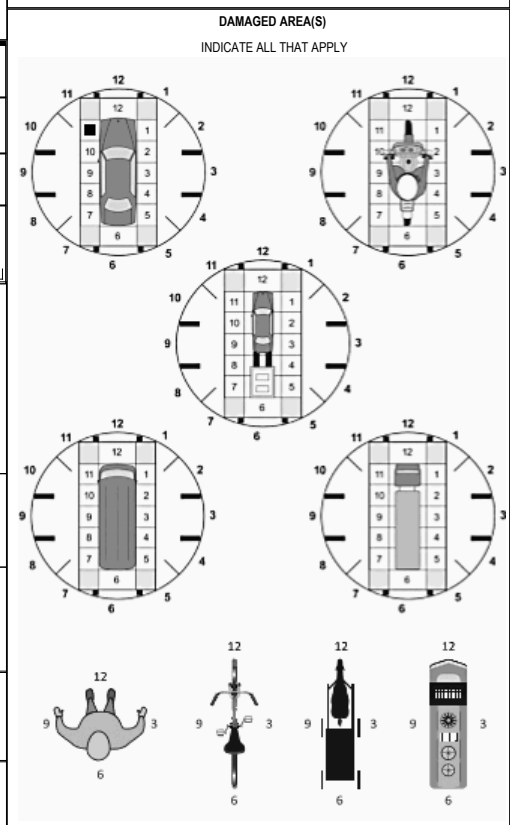
